I have attached a Community House intake form used at our facility. Know that after an initial period, a more thorough assessment of resident needs and plans is completed by one of our volunteer social workers.

My staff and volunteers are extremely adept at recognizing/handling persons that may be a "threat" to our resident community. Good organizations and community leaders, including the IFC, usually use best practices to promote public safety or deal with challenges when they occur. The IFC works diligently at Community House and HomeStart to make sure that our facilities are safe and kept safe for all residents, volunteers, staff and visitors. If, at any time, one of my staff/physicians or volunteers believe that "someone may be dangerous to self or others" a Chapel Hill Police Social Worker or Officer is called for assistance or advice. If longer-term hospitalization or services are necessitated, a FL-2 form may be completed by a psychiatrist/officer/professional and presented to an attending magistrate to determine whether person(s) requires a minimum 72 hour observation period at UNC Hospitals or like institutional setting for evaluation. The IFC rarely exercises this option, and both the Carrboro and Chapel Hill police departments partner with the IFC on these matters.

As elected officials you have the difficult task of considering the interests of a broad array of people. At times, it is difficult to balance the needs and desires of all the interests you serve. In its efforts to serve the needs of such a diverse group, the town has a long history of stewardship in promoting the needs of the less fortunate. The IFC homeless shelter would be an example of serving such a constituency.

The site being considered for the new men's homeless shelter is at the intersection of Martin Luther King Boulevard and Homestead Road, in the immediate vicinity of Homestead Park. One goal of the shelter is to create a structured program that endeavors to guide the men to independent living. The community certainly supports such a goal. The concern, however, is that the park will likely be frequented by many of the inhabitants of the shelter prior to achieving the capability for such independent living. If recent history is a guide, there will always be some degree of panhandling and loitering. We were shocked to know that you are considering to build a Homeless Man Shelter near the Homestead park, and I am writing you to express my extreme concern about the proposal.

We are residents living in the Parkside neighborhood and we have two young kids – 8-year-old and 5-year-old. We use park and aquatic center a lot. Kids love to go to park, they play basketball and baseball, they go to the community swimming pool, and we personally like to go walking everyday around the neighborhood. We felt peaceful and safe living here, and we love the wonderful school. All these are the reasons that we chosen to pay the highest property tax in the state and buy a house in this used-to-be nice neighborhood.

The situation has been changed recently. Now more than ever, we have heard of car break-ins, house break-ins, robbery, and even gunshots near where we live, which concerns all my family and my neighbors. Our own house's door had been knocked heavily during the midnight one day, which frightened me and my husband; Very often when we drove through in front of the Freedom House Rehab center, we saw groups of people hanging around and smoking; We no longer feel safe to leave kids riding bikes not near adults, even it is within our neighborhood and within our eye seeing limit; I used to be an active night walker enjoying the fresh air and calmness in the evening. However after hearing that a woman got robbed around 10:30pm in the driveway on Palafox Dr., how would I feel safe to walk again in my normal walking hours around 9:30-10:00pm?

The Homestead park and near area is such a place that is heavily-used by community for all sorts of sports soccer, baseball, basketball, swimming and such a place where residents use it for recreation, for relaxing, for community activities etc. Building a new Homeless Man Shelter right around the corner would greatly compromise the security and place huge risks on the residents living nearby.

We believe you should have already received many mails/emails from our neighbors who expressed their deep concern and we would like to add our voices too. We respectfully urge you to listen to voices from the community and continue the process of searching a suitable location for the shelter.

Honorable Mayor and Council:

Locating the Homeless Shelter within walking distance of Homestead Park and the Aquatics Center is a mistake. Clearly, you have never had to walk past a wall of Homeless people waking up in the morning from a good night's drinking and sleeping in a park. Let's not forget that the Homeless woman killed by a car up here was drunk and stumbled into the road. While the Homeless shelter will only accept those who are not on drugs and alcohol, those who are will sleep in the park. It really is that simple.

What you will do is move our Homeless problem from Franklin Street (maybe not, because begging isn't going to be easy in a Park) to Homestead Park. The result is going to be spillover crime in the surrounding neighborhoods and constant Police calls to get the Homeless to move so kids can play their soccer, baseball and basketball games.

Their will also be more petty theft in the park from the Homeless breaking windows to steal change from cars.

While I realize that the Homeless shelter has to move so you can have some new office space in the old bank building, this is a disaster waiting to happen. You might want to consider putting the Police Substation in the Aquatics Center now to save time, because it will be difficult for the front desk person to handle 10 drunk homeless men complaining about not being allowed in to shower every morning. While I firmly believe in giving people a hand up, I think there are better locations that are not near such a welcoming facility for camping out as Homestead Park. The sad fact is that moving the problem will do just that - move the problem.

The real issue is that you are taking Homeless Men - who statistically have all sorts of problems including mental illness (thanks to deinstitutionalization), alcohol and drug addiction to other things far worse - and putting them within walking distance of Senior Center, a Rehab facility (ironically enough) and a place where children play. The best that you can hope for is that your police calls in this area will increase by 50%, but I think it will likely be something a lot worse. While having them downtown is tough, having them in a place where the police presence is minimal and the opportunity for clandestine drug and alcohol use is high is just asking for nightmare that will end up on the Nightly News or America's Most Wanted.

There are better locations, but all of them will require an increased Police presence. I would be interested in hearing your plans for locating a Police Substation in this the Homestead area. With the increased development in this area, it's already needed, but if you plan to build a shelter here, build it first. Otherwise, you will be on our local news explaining the steps you are taking to stop the crime that you caused in Homestead Park.

Thank you for reading this. I know you are all responsible, reasonable, socially-conscious people who have a difficult decision and will consider not only the benefits to downtown, but to the 1,000s of residents paying in excess of \$5,000 per household in taxes who will be adversely affected and mobilized by a poor decision.

First, let me state that roughly 70% of my daily work is attempting facilitate and coordinate care for underprivileged and/or low income persons, many of whom are indigent with very high rates of SMI (Severe Mental Illness), PTSD...experiencing the entire gamut of psychosocial issues.

It is absolutely tragic what these human beings live through on a daily basis. Believe me, it is truly saddening to hear and see firsthand some of these personal stories unfold. Mr. Moran, the IFC and its supporters, volunteers and professionals should be commended and held with the utmost respect for their impassioned work. The current set of sites in Chapel Hill (and food pantry in Carrboro) that have tried to coordinate a patchwork of programs together like Freedom House, working with the Local DSS office (also in our neighborhood on Homestead Road), Temporary Residential/Public Housing, etc. is laudable and the project to end homelessness should continue to look for solutions.

However, this proposal and its site is absolutely inappropriate. What everyone in the neighborhood should know is that one of the main reasons for this site selection is the opportunity to "consolidate" services. That is, to have providers, volunteers, coordinators and crisis services all in one geographic location (our neighborhood). Between the Freedom House, the Public Housing, the existing Women's shelter and DSS office on Homestead and, at one point the notion of potentially a county jail, this will become a powderkeg location. The most alarming part of this proposal is this---the whole point of putting the shelter in this location is to concentrate the problem and its service providers into a single geographic area that is not downtown in front of merchants.

The downtown desire is to "export" the problem.

I agree with others who have sent email recently. I have a two year old daughter that we do not feel comfortable making a walk with to the park anymore (during midday) unless it is a weekend with all of the soccer groups and large numbers of people. We've had gunshots, armed robbery, 18 grown men smoking and loitering in the middle of the street and now my wife will not walk the neighborhood without me (can you blame her?). We don't even feel comfortable driving by the newly expanded Freedom House for fear of being recognized by the vehicle we are in and the driveway from which it comes with some of the stares we get.

Again, I am quite familiar with this population. For the most part (but most certainly not in all instances), persons seeking services with substance abuse treatment facilities, half-way houses, women's shelters and, public housing stay above the fray and can co-exist in residential neighborhoods. However, this is absolutely not the case with the indigent male population. We don't need to make accusations, but simply ask for some statistics from the town council that should be easy to produce and quite necessary if they are to make an informed and responsible decision:

(Note that with 50 beds, ~ 700 persons are likely to use the facility in a given year, over 500 used 30 beds last year downtown---there will be a MINIMUM of 50 residents on a given night in the proposal---suggesting that it will become a magnet site, used for overflow from adjacent towns, with budgeting for this minimum so that ancillary support staff can be placed)

- 1) How many (and what percentage) of the recipients of the IFC Men's homeless shelter's services have lived in Chapel Hill for more than a year's time? That is, are we a magnet city for these individuals?
- 2) What is the average homelessness rate for a city typical of Chapel Hill's size? Why does a town of less than 100,000 need such capacity for the indigent?
  2) How many (and what percentage) have committed a crime (and of what type) in
- the previous 5 years?

  3) How many (and what percentage) have been admitted to a state mental health facility within the previous 5 years?
- 4) How many (and what percentage) have been admitted to Duke or UNCs emergency department with a mental health crisis and what was the average amount of time between the crisis and the provision of services the IFC provided?
- 5) How many (and what percentage) have a substance abuse problem?
- 6) How many (and what percentage) have failed substance abuse treatment in the previous 5 years?
- 7)And finally (and most importantly), where do the current and candidate council members live in proximity to the proposed site? and What is their position on this proposed site and IFC solutions for homelessness?

What the neighborhood should also be made aware of is the fact that homeless shelters (particularly Men's) are quickly becoming a "safety net" mental health provider (place of discharge) in North Carolina when there is nowhere else to go. This is alarmingly frequent, and again absolutely tragic for both the patients and the overwhelmed shelters, but it is the reality of the current state situation.

These are real problems, with real individuals that need real solutions. But to put this type of facility in a residential neighborhood is absolutely irresponsible. The town is asking, practically begging, for a tragic incident with somebody's daughter, or son, or mother or father, wife or husband (in our own back yards-literally).

These words are not infused by prejudice or an apathy to the unfortunate. They are about safety---plain and simple---and anyone who has worked with this population with a modicum of honestly would agree. For every single great story about salvation, there are statistically 2 failures.

This is just one study of recidivism in mental health from the many that are available---http://psychservices.psychiatryonline.org/cgi/content/full/53/10/1290

What you should note in particular is that the authors found the "10% rate of new felonies committed against persons" was prefaced with the word "only" and that 2% committed very serious crimes. That is supposed to be good news?---so for every 100 men with Mental Health problems using the shelter that have a previous crime, "ONLY?"! 10 should be expected to commit a crime against persons and "ONLY"?! 2 should commit serious crimes?

To get an insight into the mindset of the study authors, note that the conclusion applauds the "low rate".

Typically, advocates will argue that rates of crime and recidivism are not that much different for this population than in the general population. The problem

with this logic is as follows: as a community, we don't PURPOSEFULLY concentrate the comparison individuals into a small geographic area like Men's homeless shelters do---they are spread out over the entire community.

Mental Health providers would never allow this facility to but put in their neighborhood because they know the ramifications. If you don't believe me, just ask a few. And if they say they would allow it---we will gladly inform the council of the new prospect location(s) in their residential neighborhood(s).

Dear Mayor Foy and Town Council Members,

My name is Marc Joseph. I live in the Parkside development that is next to Homestead Park with my wife and two young children. I am writing you because I am very concerned about the proposed men's shelter on MLK and I'm hoping you can address my concerns, as listed below:

- 1. The HomeStart women's shelter is supposed to be a safe haven for women and young children (often abused by the same men who will be staying at the shelter less than 1,500 yards away). Will the men's shelter be geographically too close to HomeStart by geography and create a less secure environment? I'm concerned for the safety of the women arriving and leaving the locked facility.
- 2. What will happen to the men turned away from the facility at night due to lack of space (overcrowding, drunk, ...) and in the morning when the when the shelter closes for the day in the morning? Will they be blindly turned away or taken somewhere else? The answer to this question, I think, has a significant bearing on the security issues the shelter will create in the surrounding area and provides a real gauge of how far the planning process has gone. The easy issue is to decide where to build the shelter. The real issue is what happens to the homeless men denied access and when the shelter is not open.

If the turned away residents are to be taken somewhere else, what transportation will be provided (city bus, taxi, other)? Who will pay for it (IFC, Chapel Hill, ???), and most importantly, where will they go – back to Franklin Street or to sleep on the beneches in Homestead Park?)? Do you have any occupancy statistics from the current shelter? It would be nice to know how many men are turned away each night

- 3. North Carolina sex offender law precludes sex offenders from living within 1,000 feet of the property on which any public or nonpublic "school" or "child care center" is located. The Orange United Methodist Church operates preschool and after school programs for children one year of age and up. How does the NC law come into play here?
- 4. The IFC is an independent, not-for-profit agency whose mission is to help the homeless and less fortunate. I doubt they have the financial and personal resources necessary to develop, implement, operate and fund a plan that will keep our children safe. Does the city have the resources and jurisdiction to fill in these gaps?
- 5. What is the plan for the homeless women who hang out with the men staying at the shelter who won't have a place to stay?
- 6. Is there a plan and resources available to fund collateral services like increased security in the area

### surrounding the shelter?

I don't profess to know any of the answers and I understand that the feel the shelter needs to be somewhere within the city boundaries. However, I firmly believe the city owes it to all of its citizens to properly develop and publicize an operation plan that addresses all of our concerns. We can't expect to live in a utopian society. At the same time, I feel we are entitled to know our elected leaders are taking this issue seriously rather than taking the easy way out by moving the shelter to an area many in Chapel Hill consider far away from the town's commerce and residential centers, and far away from where they meet to conduct city business (i.e. out of sight, out of mind, no more problem). Whether my last statement is true or perception is not for discussion because perception is reality and the perception is precisely as I've stated it.

Proposed Location of Homeless Shelter Irresponsible and Dangerous

First, let me state that roughly 70% of my daily work is attempting facilitate and coordinate care for underprivileged and/or low income persons, many of whom are indigent with very high rates of SMI (Severe Mental Illness), PTSD...experiencing the entire gamut of psychosocial issues.

It is absolutely tragic what these human beings live through on a daily basis. Believe me, it is truly saddening to hear and see firsthand some of these personal stories unfold. Mr. Moran, the IFC and its supporters, volunteers and professionals should be commended and held with the utmost respect for their impassioned work. The current set of sites in Chapel Hill (and food pantry in Carrboro) that have tried to coordinate a patchwork of programs together like Freedom House, working with the Local DSS office (also in our neighborhood on Homestead Road), Temporary Residential/Public Housing, etc. is laudable and the project to end homelessness should continue to look for solutions.

However, this proposal and its site is absolutely inappropriate. What everyone in the neighborhood should know is that one of the main reasons for this site selection is the opportunity to "consolidate" services. That is, to have providers, volunteers, coordinators and crisis services all in one geographic location (our neighborhood). Between the Freedom House, the Public Housing, the existing Women's shelter and DSS office on Homestead and, at one point the notion of potentially a county jail, this will

become a powderkeg location. The most alarming part of this proposal is this---the whole point of putting the shelter in this location is to concentrate the problem and its service providers into a single geographic area that is not downtown in front of merchants.

The downtown desire is to "export" the problem.

I agree with others who have sent email recently. I have a two year old daughter that we do not feel comfortable making a walk with to the park anymore (during midday) unless it is a weekend with all of the soccer groups and large numbers of people. We've had gunshots, armed robbery, 18 grown men smoking and loitering in the middle of the street and now my wife will not walk the neighborhood without me (can you blame her?). We don't even feel comfortable driving by the newly expanded Freedom House for fear of being recognized by the vehicle we are in and the driveway from which it comes with some of the stares we get.

Again, I am quite familiar with this population. For the most part (but most certainly not in all instances), persons seeking services with substance abuse treatment facilities, half-way houses, women's shelters and, public housing stay above the fray and can co-exist in residential neighborhoods. However, this is absolutely not the case with the indigent male population. We don't need to make accusations, but simply ask for some statistics from the town council that should be easy to produce and quite necessary if they are to make an informed and responsible decision:

(Note that with 50 beds, ~ 700 persons are likely to use the facility in a given year, over 500 used 30 beds last year downtown---there will be a MINIMUM of 50 residents on a given night in the proposal---suggesting that it will become a magnet site, used for overflow from adjacent towns, with budgeting for this minimum so that ancillary support staff can be placed)

- 1) How many (and what percentage) of the recipients of the IFC Men's homeless shelter's services have lived in Chapel Hill for more than a year's time? That is, are we a magnet city for these individuals?
- 2) What is the average homelessness rate for a city typical of Chapel Hill's size? Why does a town of less than 100,000 need such capacity for the indigent?
- 2) How many (and what percentage) have committed a crime (and of what type) in the previous 5 years?
- 3) How many (and what percentage) have been admitted to a state mental health facility within the previous 5 years?
- 4) How many (and what percentage) have been admitted to Duke or UNCs emergency department with a mental health crisis and what was the average amount of time between the crisis and the provision of services the IFC provided?
- 5) How many (and what percentage) have a substance abuse problem?
- 6) How many (and what percentage) have failed substance abuse treatment in the previous 5 years?
- 7)And finally (and most importantly), where do the current and candidate council members live in proximity to the proposed site? and What is their position on this proposed site and IFC solutions for homelessness?

What the neighborhood should also be made aware of is the fact that homeless shelters (particularly Men's) are quickly becoming a "safety net" mental health provider (place of discharge) in North Carolina when there is nowhere else to go. This is alarmingly frequent, and again absolutely

tragic for both the patients and the overwhelmed shelters, but it is the reality of the current state situation.

These are real problems, with real individuals that need real solutions. But to put this type of facility in a residential neighborhood is absolutely irresponsible. The town is asking, practically begging, for a tragic incident with somebody's daughter, or son, or mother or father, wife or husband (in our own back yards-literally).

These words are not infused by prejudice or an apathy to the unfortunate. They are about safety---plain and simple---and anyone who has worked with this population with a modicum of honestly would agree. For every single great story about salvation, there are statistically 2 failures.

This is just one study of recidivism in mental health from the many that are available--- http://psychservices.psychiatryonline.org/cgi/content/full/53/10/1290

What you should note in particular is that the authors found the "10% rate of new felonies committed against persons" was prefaced with the word "only" and that 2% committed very serious crimes. That is supposed to be good news?---so for every 100 men with Mental Health problems using the shelter that have a previous crime, "ONLY?"! 10 should be expected to commit a crime against persons and "ONLY"?! 2 should commit serious crimes?

To get an insight into the mindset of the study authors, note that the conclusion applauds the "low rate".

Typically, advocates will argue that rates of crime and recidivism are not that much different for this population than in the general population. The problem with this logic is as follows: as a community, we don't PURPOSEFULLY concentrate the comparison individuals into a small geographic area like Men's homeless shelters do---they are spread out over the entire community.

Mental Health providers would never allow this facility to but put in their neighborhood because they know the ramifications. If you don't believe me, just ask a few. And if they say they would allow it---we will gladly inform the council of the new prospect location(s) in their residential neighborhood(s).

# Mayor Foy and Town Council:

It is with great disappointment and antipathy that I am forced by these circumstances, to publicly voice my objection for the first time since arriving in Chapel Hill. As a former resident of New York, who commuted to Manhattan every weekday for the past 25 years, I am well versed in dealing with aggressive panhandlers. When I moved to Chapel Hill a year ago, it was my hope that my wife and children could limit such experiences, but I now find myself on the verge of being wrong.

We chose Chapel Hill after long and careful research, specifically and knowingly opting to spend more for our home, and pay among the highest tax rates in the entire state. We thought the Parkside neighborhood was a wonderful place to settle with our two elementary school aged girls, with it's proximity to the schools and Homestead Park fields, walking paths and swimming pool. Yet now, for some reason I cannot fathom, you are actually considering placing a homeless shelter on the edge of our neighborhood, negating all of those advantages.

As a fairly new resident, I would be remiss in trying to quote details regarding increasing crime rates, and rules of proximity for such a location. I believe my neighbors have made those points abundantly clear. What I can say emphatically, is that for *ANY* reason, giving life to this idea is disgraceful. There is no excuse for inviting the wayward into our neighborhood. Panhandlers may be anonymously bypassed while shopping downtown, but on my street, I would fear for the safety of my home and family. I don't particularly enjoy the idea that the Town Council would even deliberate over giving a group of homelss the opportunity to watch my home and those of my neighbors, every day.

I urge you in the strongest way possible, to give real consideration to what affect this shelter would have on the well being of the residents and the long term property values of these adjacent neighborhoods. If the issue is truly about consolidation of services, move all of them to another open space, outside the residential neighborhoods. Is there no industrial area for this shelter? If the issue is about money, I would like an explanation as to how this particular location will help the Chapel Hill budget.

Our home issupposed to be the place we feel secure at the end of the day. Our home is supposed to be the place for my children to shut out the ills of the world. Would you feel secure if this shelter were in your backyard?
