- BY JOINT LOCAL AND UNC POLICE, INCLUDEING CRIMES THERIN AND REPORTS ' BOARD
- 4) MORE THAN FOUR CRIMINAL COMPLAINTS BY RESIDENTS OR HOME OWNERS AGAINST FRAT MEMBERS AND FRAT OFF CAMPUS PARTY HOUSES IN THE NORTHSIDE NEIGHBORHOOD RESULT IN A TEN YEAR BAN ON FRAT MEMBERS LEASING AND PARTYING IN NORTHSIDE.
