Dear Chris:

This letter is a follow up to a letter I sent to Cal Horton on May 17, 2004 requesting that Habitat for Humanity of Orange County be permitted to use the remaining Community Development Block Grant (CDBG) funds approved for Rusch Hollow for infrastructure construction instead of land purchase as stated in the performance agreement.

I am attaching an updated budget to replace the budget attached to the performance agreement dated June 2002. Since the original budget was developed, the project has undergone a number of revisions, including a change in the route of the sewer extension, and the addition of a storm water bioretention basin as required under the new Land Use Management Ordinance, which was adopted after our original budget was developed. As a result of these and other changes that occurred during the process of receiving approval for a special use permit from the Town of Chapel Hill, the budgeted cost of the infrastructure has gone from \$350,000 to \$420,000.

Given this increase in cost since our original projections, the remaining \$19,500 in CDBG funds that have been approved for this project for land purchase are necessary to help Habitat close the gap in infrastructure funding.
