

Dear Madam Mayor and Council Members:

We are writing today with a formal petition for assistance from the Town of Chapel Hill.

WHEREAS the homeowners along Cedar Fork Creek are suffering increasing problems with erosion and flooding, and

WHEREAS the Town of Chapel Hill is responsible for the effective management of storm water run-off within the Town boundaries, and

WHEREAS the Town of Chapel Hill has approved OWASA construction projects in and around the Cedar Fork Creek bed, and

WHEREAS that construction has seriously destabilized the banks of Cedar Fork Creek, resulting in dramatic widening of the creek and increased flood risks to nearby homes,

NOW THEREFORE the undersigned Citizens respectfully request that the Chapel Hill Town Council direct the Town Manager to provide appropriate planning, engineering and remediation assistance to stabilize the creek bed, reduce the amount of erosion, and mitigate the threat of flooding to nearby homes. We further request that this support be provided in an expedited manner to coincide with the upcoming restoration of Eastwood Lake.
