The minutes of the regular meeting of November 24, 1975 were duly considered and corrections were offered. On motion by Alderman Smith, seconded by Alderman Gardner, said minutes were approved for official recording as corrected.

Remarks By Outgoing Members Of The Board Of Aldermen.

As there were no resolutions and recognitions at the present, Mayor Lee recognized Alderman Rancer. After thanking the citizens for the opportunity to serve, as well as the opportunity to learn, about the workings of municipal government. Alderman Rancer presented the following statement:

As a member of the Water & Sewer Authority, I would hope that the new Board of Aldermen would accept the bid documents and agreements with as little change as possible. The Authority has worked long and diligently, ten months I believe, in formulating these documents with the competent legal guidance of Emery Denny and cooperation of County Attorney Lonnie Coleman, Carrboro Attorney William Staton and the Authority Attorney Claude Jones. In preparing these documents we gave a little and received a little. It seems to me that should negotiations be started again that the whole project may be scrapped by the Church Commission, the alternative will be Duke Power Company. I am sure that the citizens of the communities involved would not want that.

Alderman Rancer vacated his seat after the presentation of his nameplate by Mayor Lee.

Mayor Lee then recognized Alderman Welsh whose remarks included appreciation of all the citizens who attend Aldermen's meetings, the administration, the employees, the Town Attorney, the media, the Mayor and other members past and present of the governing Boards with whom she has served. "There were difficult times and there were easy times but members transcended differences and have worked harmoniously for public interest through respect for disparate views. As a result the town has moved steadily towards progress and stability and will continue to improve and advance so long as the new Mayor and Board members place the public good above private and selfish interests." After thanking the assembly, on presentation of her nameplate by Mayor Lee, she vacated her seat.

### Remarks By Outgoing Mayor, Howard N. Lee.

In Mayor Lee's outgoing remarks he expressed both the shortness and eternity of his term of office and his gratitude to the citizens of Chapel Hill for having the faith and confidence in him to elect and support him as Mayor:

There have been times when I could have thrown up in despair and believed that there was not a chance that a person like myself could come from a sharecropper's farm in Georgia and have the good fortune of gaining the confidence of so many people who would entrust me with the mayoralship, the highest elected office of their city. But the people of Chapel Hill did and while there are those who have been very generous in their comments to give me credit for a lot of things, it is I who owe the credit and the honor to the citizens of Chapel Hill for taking the chance on an unknown entity. And though more than many people who have been willing to be generous in their comments, giving me credit for a lot of things during the six and a half years, that credit I do not deserve as a lone person. I happen to be in the forefront, I happen to have the good fortune to sit as Mayor and I happen to be able to work with a lot of good people who make those things happen and so there are people who are present here this evening who deserve the credit and there are people who no longer sit as members of the Board who deserve the credit. I owe a great deal of thanks and appreciation to Emery Denny whom I consider a person of the highest integrity, a man of sincere honesty and one who is willing to give the kind of support to a person in my position as needed. I owe a great deal of appreciation to Dave Roberts who served as both Tax Collector and Town Clerk and has been more than just a town employee but a very strong friend and in many ways an advisor. I owe a great deal of thanks to department heads such as Chief Blake, Chief Hilliard who is new here, and Chief Lloyd who has run an outstanding Fire Department during my administration. Many of you heard me say many times that I am not particularly fond of the Town Manager form of government. I leave with that same feeling. But I also leave with a different feeling. I think that if the Town Manager form of government is to ever work, is to convince me that I was wrong, it has the best chance in Chapel Hill in the person of Kurt Jenne.... Let me say that only good things can happen with the kind of people the citizens of Chapel Hill have elected to take over. We must see this as a symbol of why we should not ever lose confidence in our government. We must never lose faith in the political process and we must give our leaders every opportunity to provide the leadership that we have cast upon them. Those people who have been elected, whom I've known for quite a while, I feel more than capable, more than able of picking up the reins...

At the conclusion of his remarks, Mayor Lee presented the key to the city to Mayor-elect Wallace and received in return his well-pounded gavel. Mayor Lee then administered the Oath of Office to Mr. Wallace.

## Triangle J Council Of Governments - Appointment.

Expressing his hope of assuming the responsibilities of representing the Town of Chapel Hill as delegate to the Triangle J Council of Governments in the future, Mayor Wallace appointed Mayor pro tem Marshall as said delegate on an interim basis.

Mayor Wallace called a five minute recess of the Board.

Mayor Wallace reconvened the regular meeting of Board of Aldermen to address the business of the evening.

## Harriss-Conners Chevrolet, Modification Of Special Use Permit.

Action on this request had been delayed from the meeting of November 24, 1975. In order to fill in the newly-sworn aldermen, the background of the request was presented by Planning Director Jennings. Questions and discussion centered on the enforceability of stipulations attached to issuance of Special Use Permits. After struggling with various approaches, ALDERMAN HOWES MOVED, SECONDED BY ALDERMAN GARDNER THAT THE BOARD OF ALDERMEN APPROVE THE MODIFICATION OF THE SPECIAL USE PERMIT FOR 1) THE ADDITIONAL SAAB SIGN LOCATED BEHIND THE REQUIRED FRONT BUILDING LINE; 2) THE RELOCATION OF THE EXISTING BMW SIGN BEHIND THE REQUIRED FRONT BUILDING LINE: AND 3) THE MODIFICATION OF THE LANDSCAPE PLAN SUBJECT TO THE FOLLOWING:

- 1. That a minimum of fourteen (14) crepe myrtles be planted by March 1, 1976, eight (8) along U.S. 15-501 and six (6) along the property line abutting Old Durham Road, all spaced no more than sixty (60) feet apart, as designated on the plan submitted November 21, and that the crepe myrtles be a minimum of six (6) to ten (10) feet in height when planted.
- 2. That the crepe myrtles be supplemented by a tight evergreen hedge not less than six feet in height within three years of planting along Old Durham Road. This hedge must be planted by Janaury 1, 1977.
- 3. That all outdoor storage of refuse including automobile parts and tires be screened on at least three sides by a wall or fence of solid appearance not less than six feet high to conceal such areas from abutting residential uses and street rights-of-way.

- That any and all planting as required shall be properly maintained, and that any and all planting which dies during the life of the Special Use Permit shall be replaced with planting of the same species and approximately the same size during the next planting season.
- 5. That these stipulations replace all previous stipulations.

SAID MOTION PASSED BY A VOTE OF FIVE TO FOUR WITH ALDERMEN HOWES, MARSHALL, VICKERY, GARDNER AND MAYOR WALLACE SUPPORTING AND ALDERMEN SMITH, EPTING, SILVER, AND COHEN OPPOSING. During the discussion, Mayor Wallace and the Board asked Town Manager Jenne to advise the Board on civil penalties that might be used to enforce approved stipulations.

# University Mall Sign Plan, Modification of Special Use Permit.

After presentation by Planning Director Jennings and discussion by the Board, ALDERMAN SILVER MOVED, SECONDED BY ALDERMAN MARSHALL THAT THE MODI-FICATION OF THE "UNIVERSITY MALL" SIGN AND THE TWO "TEXACO" SIGNS BE AP-PROVED, BUT THAT THE "MCDONALD'S" SIGN BE DENIED. SAID MOTION WAS DEFEATED BY A VOTE OF FOUR TO FIVE WITH ALDERMEN SMITH, EPTING, VICKERY, COHEN AND MAYOR WALLACE OPPOSING AND ALDERMEN MARSHALL, SILVER, GARDNER AND HOWES SUPPORTING. 
