

Mayor Wallace called the meeting to order. Present were:

Also present were Town Manager K. Jenne and Town Clerk D. Roberts. Alderman Epting was excused.

## Resolution Authorizing the Mayor to Execute an Audit Agreement

The Audit Committee's report had been distributed. Alderman Vickery stated they were recommending that Peat, Marwick & Mitchell be appointed as auditors. Five proposals had been received and the committee had chosen to interview three because of their capability and experience in performance auditing. References were obtained and followed-up. Two firms had superior experience in performance auditing. references for Peat, Marwick & Mitchell were most enthusiastic. A bad reference for Price Waterhouse's financial auditing had decided the committee on Peat, Marwick & Mitchell. Alderman Howes noted that there was a letter written to the Alderman offering the services of Whitaker and Wagoner in the performance auditing. He wished to point out that these individuals were offering their services as individuals, and without compensation.

ALDERMAN VICKERY MOVED, SECONDED BY ALDERMAN HOWES, ADOPTION OF THE FOLLOWING RESOLUTION.

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AUDIT AGREEMENT

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that the Board hereby authorizes the Mayor to execute on behalf of the Town a Contract to Audit Accounts for Fiscal Year 1977-78 with Peat, Marwick and Mitchell.

This the 30th day of March, 1978.

Alderman Smith asked for a follow-up on the statistics of black and female employees in Peat, Marwick & Mitchell, as they listed their affirmative action program as one of their qualifications. THE MOTION WAS CARRIED BY UNANIMOUS VOTE OF 7 TO 0.

On motion by Alderman Smith, seconded by Alderman Howes, the Board adjourned into Executive Session to discuss land acquisition.

## Resolution Authorizing Condemnation

The Board reconvened after Executive Session. ALDERMAN VICKERY MOVED, SECONDED BY ALDERMAN SMITH, ADOPTION OF THE FOLLOWING RESOLUTION.

## RESOLUTION AUTHORIZING CONDEMNATION

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that the Board of Aldermen hereby authorizes the Town Attorney to negotiate with Mr. Frank Hairston, Jr., to purchase a tract on the west side of Mitchell Lane adjoining the Hargraves Center at its appraised value; and

BE IT FURTHER RESOLVED that if a negotiated purchase cannot be made, the Town Attorney is hereby authorized to institute condemnation proceedings to acquire said tract, depositing the appraised value with the Clerk of Court.

This the 30th day of March, 1978.

THE MOTION WAS CARRIED BY UNANIMOUS VOTE OF 7 TO 0.
