MINUTES OF A REGULAR MEETING OF THE MAYOR AND BOARD OF ALDERMEN TOWN OF CHAPEL HILL, MUNICIPAL BUILDING, JUNE 26, 1978, 7:30 P.M.

Mayor Wallace called the meeting to order. Present were:

Also present were Town Manager, K. Jenne, Town Attorney, E. Denny, and Town Clerk, D. Roberts.

Mayor Wallace announced that the Manager had asked for the Board to meet in Executive Session to discuss personnel matters. The Executive Session was delayed until Alderman Vickery's arrival.

Minutes

On motion by Alderman Smith, seconded by Alderman Epting, the minutes of June 12, 1978, were approved as amended.

Consideration of Calling a Second Public Hearing on Sewer Assessments

Alderman Howes stated that at the time of the public hearing on sewer assessments for the Smith/Coolidge and Sourwood areas, Dr. Capowski had raised a question about the notice of the hearing saying that it did not give an accurate picture of how much money was involved in the assessment. Although Mr. Harris is reluctant to give a figure because of the possibility of rising costs, Alderman Howes felt a range should be specified for the residents. The figures would be substantially higher than expected by most residents. Therefore, Alderman Howes proposed another hearing be held with the residents notified of the approximate cost of the assessment. (Alderman Vickery came in.) ALDERMAN HOWES MOVED, SECONDED BY ALDERMAN BOULTON, ADOPTION OF THE FOLLOWING RESOLUTION.

A PRELIMINARY RESOLUTION CONCERNING SANITARY SEWER IMPROVEMENTS SERVING THE SOURWOOD AND SMITH/COOLIDGE AREAS

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that:

- 1. The Board of Aldermen of the Town of Chapel Hill intends to undertake sanitary sewer improvement projects as follows:
- Area I: Sourwood, serving properties abutting portions of: Sourwood Drive, Sourwood Circle, Bartram Drive, Shady Lane, Ashe Place, Spring Dell, Coker Drive.
- Area II: Smith/Coolidge, serving properties abutting portions of: Coolidge Street, Dawes Street, Smith Avenue, Old Pittsboro Road, West Lane, Pittsboro Road, Woodland Road, Pine Bluff Trail, Monroe Street.
- 2. The project shall consist of the installation of eight-inch sewer laterals.
- 3. It is anticipated that the basis for assessing said project costs shall be actual costs of the installation of said sewers, and that said costs so computed be assessed against the property owners equally for each lot which can be served with sewer by reason of said sewer improvements;
- 4. The amount of said assessment may be paid in full without interest at any time before the expiration of 30 days after the date of the notice of confirmation of said assessment has been published, or may be paid in 10 equal annual installments each bearing interest on the unpaid balance at the rate of 6% per annum from the date of said confirmation;

BE IT FURTHER RESOLVED by the Board of Aldermen of the Town of Chapel Hill, that a public hearing is hereby called on this proposed project on the 24th day of July, 1978 in the Meeting Room of the Municipal Building, Chapel Hill, North Carolina at 7:30 P.M.; and

BE IT FURTHER RESOLVED that at least 10 days before the date set for said public hearing, that notice of said hearing and the adoption of the Preliminary Resolution be published in the Chapel Hill Newspaper, and that a copy of said Notice and this Resolution be mailed by first class mial at least 10 days prior to said hearing to all property owners whose property may be subject to assessment by reason of this project as shown on the County Tax Records.

NOTICE OF THAT PUBLIC HEARING TO INCLUDE AS CLEAR INFORMATION AS POSSIBLE ABOUT THE IMPACT OF THE ASSESSMENTS ON THE PROPERTY OWNERS AS WELL AS BE COORDINATED WITH OWASA TO BE SURE THOSE ASSESSMENTS ARE INCLUDED. THE MOTION WAS CARRIED BY UNANIMOUS VOTE OF 8 TO 0.

Alderman Howes suggested the second meeting in July for this hearing.

Resolutions of Appreciation for Woodrow Edmonds and Marilyn Christopher

Mayor Wallace read the following resolutions of appreciation for the service of Woodrow Edmonds and Marilyn Christopher to the town.

WHEREAS, Woodrow Edmonds served as a member of the Chapel Hill Planning Board from February 1973, through June 1978, and

WHEREAS, Mr. Edmonds contributed long hours of service to the Town of Chapel Hill demonstrating dedication in the pursuit of a better planned community, and

WHEREAS, Mr. Edmonds provided determined leadership during his five years of service on both the Planning Board and Zoning Committee;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Board of Aldermen of the Town of Chapel Hill, on behalf of all of the citizens, express deep appreciation to Woodrow Edmonds, for the excellent services rendered; and

BE IT FURTHER RESOLVED that this resolution be signed by the Mayor and each member of the Board of Aldermen and a copy be duly filed with the permanent records of the Town of Chapel Hill.

WHEREAS, Ms. Marilyn Christopher served as a member of the Recreation Commission from December 1976, until May 1978, and

WHEREAS, Ms. Christopher contributed many hours of service to the Town of Chapel Hill in an effort to provide recreation for the community, and

WHEREAS, Ms. Christopher accepted the responsibilities of her appointment and performed with dedication and loyalty;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and members of the Board of Aldermen of the Town of Chapel Hill, on behalf of all the citizens, express sincere appreciation to Ms. Christopher; and

BE IT FURTHER RESOLVED that this resolution be signed by the Mayor and each member of the Board of Aldermen and a copy be duly filed with the permanent records of the Town of Chapel Hill.

ALDERMAN EPTING MOVED, SECONDED BY ALDERMAN COHEN, ADOPTION OF THE RESOLUTIONS. THE MOTION WAS CARRIED BY UNANIMOUS VOTE.

ALDERMAN THORPE MOVED, SECONDED BY ALDERMAN EPTING, THAT THE BOARD ADJOURN TO EXECUTIVE SESSION TO DISCUSS PERSONNEL MATTERS. THE MOTION WAS CARRIED BY UNANIMOUS VOTE. After returning from the Executive Session Mr. Jenne announced that he had accepted a position as a Visiting Fellow at the Woodrow Wilson School for Public and International Affairs, at Princeton University during the coming academic year. His status with the town during the time had not been decided. He and the Board of Aldermen hoped to resolve this with an announcement being made sometime during the last weeks of July.

Petitions and Requests

Mayor Drakeford of the Town of Carrboro stated the bus service received by Carrboro during the last year had been excellent. He then presented a petition requesting a non-exclusive franchise to operate a bus service between the Town of Carrboro and the University and Hospital. They were looking at all alternatives for providing bus service to the citizens of Carrboro. This would not close negotiations with the Town of Chapel Hill. Mayor Wallace read the franchise requsted.

> AN ORDINANCE GRANTING TO THE TOWN OF CARRBORO A NON-EXCLUSIVE FRANCHISE TO PROVIDE A TRANSPORTATION SERVICE ON CERTAIN STREETS WITHIN THE TOWN OF CHAPEL HILL

WHEREAS, it appears to the Board of Aldermen of the Town of Chapel Hill, and the Board so finds as a fact, that it would be in the public interest and that public convenience and necessity require that the town grant to the Town of Carrboro a non-exclusive franchise to render motor bus transportation service as hereinafter provided on certain streets within the corporate limits of the Town of Chapel Hill;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL:

That consent and permission be and the same is hereby granted and given to the Town of Carrboro to engage in the business of furnishing passenger transportation service as hereinafter provided over present and future streets of the Town of Chapel Hill along routes established from time to time by mutual agreement between the Board of Aldermen and the Town of Carrboro, and to that end the Town of Carrboro is hereby authorized to operate buses and other transportation vehicles over, along, and across streets, avenues, highways, and other public ways. The terms and conditions of this grant are as follows:

- 1. Service to be rendered. The operation of buses and other passenger transportation vehicles within the town shall be primarily to provide round trip transportation service for residents of the Town of Carrboro from locations within the Town of Carrboro to designated locations within the University of North Carolina and the Chapel Hill Central Business District.
- 2. Routes and Stops. Subject to the above provision for modification of routes by mutual agreement, the following routes are hereby approved:
 - (a) The route currently operated by the Town of Chapel Hill pursuant to agreement with the Town of Carrboro and known as the "C" route.
 - (b) That portion of the route currently operated by the Town of Chapel Hill and known as the "N" route that extends between West Rosemary Street near the Chapel Hill-Carrboro boundary and the N.C. Memorial Hospital. (The route may run down West Franklin Street in lieu of West Rosemary Street.)

Buses operated pursuant to this franchise may stop for the purpose of loading and unloading passengers or to layover only at places so designated by signs along the prescribed routes.

3. Insurance. The Town of Carrboro shall indemnify and hold the Town of Chapel Hill free and harmless from all liability, loss, damage, cost and expense by reason of the negligent operation or maintenance of vehicles or equipment in the transportation

service authorized by this franchise, and the Town of Carrboro shall carry such amounts of public liability insurance as will adequately protect the public and the Town of Chapel Hill.

- 4. Term of Franchise. This franchise shall continue and exist for a period of ten years from and after its final approval by the Board of Aldermen.
- 5. Non-Exclusive. The franchise granted to the Town of Carrboro by the Board of Aldermen of the Town of Chapel Hill shall be non-exclusive and shall in no way prohibit or prevent the Board of Aldermen of the Town of Chapel Hill from granting other franchises for passenger transportation service over any streets with the Town of Chapel Hill.
- 6. Assignment. This franchise and the rights contained herein shall not be sold, assigned, or in any manner transferred without the prior approval of the Board of Aldermen, but the Town of Carrboro may exercise all of the rights and privileges granted herein either through a transportation service owned and operated solely by the Town of Carrboro or a system any part of which (including employees, equipment, maintenance, management services, etc.) is obtained through a lease or other contractual arrangement with any party.

ALDERMAN EPTING MOVED, SECONDED BY ALDERMAN HOWES, THAT THE FRANCHISE MATTER BE REFERRED TO THE TRANSPORTATION BOARD, THAT THE TRANSPORTATION BOARD AND THE ADMINISTRATION SHOULD CONTINUE TO MEET TO NEGOTIATE WITH APPROPRIATE OFFICIALS IN CARRBORO WITH RESPECT TO THE PROVISION OF SERVICE BY THE CHAPEL HILL TRANSPORTATION SYSTEM INTO CARRBORO, AND THAT THE TRANSPORTATION BOARD AS WELL AS THE TOWN ADMINISTRATION MEET AND DISCUSS THE IMPLICATIONS OF THE FRANCHISE, AND BRING AN EARLY REPORT BACK TO THE BOARD. Alderman Cohen asked if this report was to be by July 12, so that the Board could act before its August recess. Alderman Epting said the report should be as soon as possible but that it should only be after a complete study. Mayor Drakeford asked for as expeditious report as possible. If they did not get the franchise before fall, they would have no alternative to Chapel Hill's service. Mr. Jenne asked that the staff have access to additional information to adequately evaluate the franchise, and that he be given this information in a timely manner. Mayor Drakeford responded that Carrboro would provide as much information as any other such enfranchised group had been asked to provide.

Alderman Vickery did not feel it would be a responsible position for the Board to take to acquiesce to a service which only served the citizens of Carrboro when there are citizens in Chapel Hill who also want to travel from Chapel Hill to Carrboro. He also wanted the staff to consider pricing to insure compatability with our system, transfers between routes, and that the cost of the franchise reflect the damage done to Chapel Hill streets by Carrboro busses. Alderman Thorpe commented that ten years was too long for a franchise. Mr. Sherwood Ward stated that without the franchise or an indication of good faith from Chapel Hill, there would be no need for Carrboro to pursue alternatives. They wanted to provide the best viable alternative for their citizens. THE MOTION WAS CARRIED BY UNANIMOUS VOTE.

Alderman Cohen stated that he had heard advertisements on the radio that Broadmoore Apartments in Durham would be providing bus service to Chapel Hill. As they had not applied for a franchise, he asked that the Manager write to them.

Alderman Thorpe asked that the matter of the Committee to oversee the Joint Park-Ride Study be placed on the agenda. Mayor Wallace said it would be considered after all petitions and requests.

Committee to Oversee the Joint Park-Ride Study

Alderman Howes said the letter from Mr. Lathrop suggested two committees be set up. One of these committees would be overseeing the park-ride study. Mayor Wallace did not believe that members of the Board of Alderman or the University Administrators with authority to make decisions should be on this committee since it would be advising the University and the Board. Alderman Boulton agreed. Mayor Wallace suggested the Planning Board chairman and the Transportation Board chairman be appointed. Alderman Howes asked if the university's appointee to the Transportation Board might also serve on this committee. Mr. Lathrop stated the appointment would probably be up to the Chancellor. But, he felt that the Vice Chancellor for Business and Finance would provide a more practical contact with the university in planning. Alderman Howes agreed that Mr. Temple would be an appropriate appointee to the committee. Alderman Howes suggested the initial committee should consider what the nature of the continuing committee ought to be. It could then evaluate whether the Planning and Transportation Board chairmen and Mr. Temple should constitute this continuing committee or whether it should have other members. The first committee would be set up as in Mr. Lathrop's letter. Mr. Lathrop stated the correspondence between Mr. Jenne and Mr. Temple of June 1, referred to in his letter, spelled out the first committee of five's objectives. ALDERMAN HOWES MOVED, SECONDED BY ALDERMAN EPTING, THAT THE SPECIAL COMMITTEE TO OVERSEE THE PARK-RIDE STUDY BE ESTABLISHED IN ACCORDANCE WITH THE RECOMMENDATIONS OF MR. LATHROP, MS. PARKER AND MR. TEMPLE TO INCLUDE THE CHAIRMAN OF THE PLANNING BOARD, THE CHAIRMAN OF THE TRANSPORTATION BOARD, THE DESIGNEE OF THE CHANCELLOR, THE ADMINISTRATIVE DIRECTOR OF NCMH, AND A REPRESENTATIVE OF STUDENT GOVERNMENT. THE MOTION WAS CARIED BY UNANIMOUS VOTE.

Resolution Approving a Preliminary Sketch for the 1217 East Franklin Street Subdivision

Mr. Berger stated the applicant wished to subdivide the property currently occupied by Vine's Veterinary Hospital into two lots. The property is zoned suburban commercial. Approximately 5600 sq. ft. of the property is in the flood plain and has been dedicated as conservation and greenway easement. The applicant has no immediate plans for the use of the property. The accessory building on the lot would be removed if the second lot was developed. Alderman Cohen asked if the owner would be able to develop the property differently with the subdivision than he could currently. Mr. Berger responded that currently he would need a special use permit for two buildings, which could be built without the special use permit when the property was divided. In suburban commercial zoning there is no side yard requirement, but there are parking requirements and a 35' setback requirement. Mr. Denny explained that the subdivision could not be denied as long as ordinances were complied with. ALDERMAN EPTING MOVED SECONDED BY ALDERMAN HOWES, ADOPTION OF THE FOLLOWING RESOLUTION.

A RESOLUTION APPROVING A PRELIMINARY SKETCH FOR THE 1217 EAST FRANK-LIN STREET SUBDIVISION LOCATED ON CHAPEL HILL TOWNSHIP TAX MAP 77, BLOCK B, LOT 13A

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that the Board hereby approves the preliminary sketch dated January 8, 1978 for the 1217 East Franklin Street Subdivision located on Chapel Hill Township Tax Map 77, Block B, Lot 13A subject to the following requirements:

- That utility easements and water and sewer line improvements serving new construction shall be of the standards of OWASA.
- That a storm water drainage plan be approved by the Town Manager prior to the start of new construction of improvements.

Resolution Granting a Modification of the Special Use Permit for Village West Condominiums to Frank G. Umstead

Mr. Berger stated the original special use permit had been issued in 1973 for 167 units located at the end of Umstead Drive. The applicant, in a modification, was required to provide a 30 ft. right-of-way along the property line to be joined with a right-of-way along the town's cemetery to comprise Jay Street. By error a foundation for one of the units was constructed in the right-of-way. The situation could be corrected by reducing the requirement for right-of-way from 30 ft. to 20 ft. The staff felt the 50 ft. right-of-way would be adequate to serve the properties along the railroad. ALDERMAN KAWALEC MOVED, SECONDED BY ALDERMAN EPTING, ADOPTION OF THE FOLLOWING RESOLUTION.

A RESOLUTION GRANTING A MODIFICATION OF THE SPECIAL USE PERMIT FOR VILLAGE WEST CONDOMINIUMS TO FRANK G. UMSTEAD

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that the Special Use Permit granted to Frank G. Umstead on April 9, 1973 for the Village West Condominiums on Umstead Drive is herebymodified to allow a reduction in the required right-of-way width located along the property boundary adjoining the Town Cemetery from 30 feet to 20 feet as shown on plans dated January 26, 1976 subject to the following:

- 1. That the width of the public right-of-way required along the property boundary adjoining the Town of Chapel Hill Cemetery be reduced from 30 feet to 20 feet, the width of the public right-of-way along the western property boundary shall remain at 30 feet.
- 2. That except as modified herein, all other special terms, conditions, and stipulations heretofore made applicable to the Special use Permit be continued in effect, and as so modified the Board finds that with all stipulations and conditions as modified, the use continues to meet the four requisite findings set forth in the initial Special Use Permit.

BE IT FURTHER RESOLVED that the Board of Aldermen finds that the use as modified continues to meet the four findings made by the Board of Aldermen on April 9, 1973 and subsequently modified.

This the 26th day of June, 1978.

Alderman Smith asked who was responsible for seeing that buildings were not built on the right-of-way. He did not think the town should correct the developer's mistake. Mr. Jenne explained that the errors did not arise in the plans, but usually in the surveying of the property. In comparing this with the Miketa property however, the staff had looked in both instances at the intent of the developer and the harm done to the town before making its recommendation.

Mr. Greys, representing Mr. Goforth, stated that the foundation did not encroach in the right-of-way, but in the setback for the building. The developers had not secured a copy of the amendment to the special use permit showing the 60 ft. right-of-way when they brought the project. THE MOTION WAS CARRIED BY A VOTE OF SEVEN TO ONE WITH ALDERMEN BOULTON, COHEN, EPTING, HOWES, KAWALEC, THORPE AND VICKERY SUPPORTING AND ALDERMAN SMITH OPPOSING.

Alderman Boulton asked why the free bus service was all over town and not just downtown. Mr. Jenne explained that the activities were an effort by all merchants and the town had been requested to have the service all over the Town. It was limited to the hours of 10 to 4 and would miss most of the peak hour traffic for commuters. THE MOTION WAS CARRIED BY VOTE OF SEVEN TO ONE WITH ALDERMEN BOULTON, COHEN, HOWES, KAWALEC, SMITH, THORPE AND VICKERY SUPPORTING AND ALDERMAN EPTING OPPOSING.

Resolution Establishing Free Bus Service in Chapel Hill on July 14, 1978

ALDERMAN COHEN MOVED, SECONDED BY ALDERMAN HOWES, ADOPTION OF THE FOLLOWING RESOLUTION.

A RESOLUTION ESTABLISHING FREE BUS SERVICE IN CHAPEL HILL ON JULY 14, 1978

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that the Board hereby suspends all fares on Chapel Hill Transportation System buses between the hours of 10:00 a.m. and 4:00 p.m. on July 14, 1978, to aid in the observance of Hot Diggity Day.

A RESOLUTION DIRECTING CLOSING OF A PORTION OF RIDGE ROAD FOR ONE DAY

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that the Board hereby closes to vehicular traffic the portion of Ridge Road between Stadium Drive and the south entrance of the Rams Head Lot on July 4, 1978, between the hours of 3:30 pm and 8:30 pm.

In response to a question from Alderman Cohen, Mr. Bob Boise stated that the activities planned were different from past years and would start at a different time.

Resolution Authorizing Grant of an Underground Utilities Easement

ALDERMAN HOWES MOVED, SECONDED BY ALDERMAN EPTING, ADOPTION OF THE FOLLOWING RESOLUTION.

 \cdot A RESOLUTION AUTHORIZING GRANT OF AN UNDERGROUND UTILITIES EASEMENT

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill that the Board hereby authorizes the Town Manager and Town Clerk to execute an underground utilities easement upon the Hargraves Center site allowing installation of a primary cable to the proposed tennis court light.

THE MOTION WAS CARRIED BY UNANIMOUS VOTE OF 8 TO 0.

Ordinances and Resolutions Regarding Traffic Regulations

Mr. Jenne explained that the town needed to adopt ordinances dealing with traffic regulations for the newly annexed areas. 

WHEREAS, Mr. Turner gave long hours of dedicated service as a member of the Library Board, and made the invaluable contribution of his professional knowledge and expertise in long-range planning, goal-setting, and policy-making to provide and define future growth of library service to the community;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Board of Aldermen of the Town of Chapel Hill, on behalf of all of the citizens, express deep appreciation to Alvis G. Turner, for the excellent services rendered; and

BE IT FURTHER RESOLVED that this resolution be signed by the Mayor and each member of the Board of Aldermen and a copy be duly filed with the permanent records of the Town of Chapel Hill.

Report on a Request for a Franchise to Operate a Public Transit System in the Town of Chapel Hill

Mr. Lathrop stated that the Transportation Board met in a special meeting to consider the question of a franchise to Carrboro. The Board had voted unanimously 7 to 0 to recommend denying the franchise. Their main reasons were concern about a second public transit system operating in what is essentially a single community, dismay over the lack of communication and cooperation between the two towns, and the possible effect on Chapel Hill's
