MINUTES OF A SPECIAL MEETING OF THE MAYOR AND COUNCIL OF THE TOWN OF CHAPEL HILL, MUNICIPAL BUILDING, MONDAY, JULY 15, 1985 7:30 P.M.

Mayor Joseph L. Nassif called the meeting to order. Council Members present were:

Also present were Acting Town Manager Ron Secrist, Assistant Town Manager Sonna Loewenthal, and Acting Town Attorney Michael Patrick.

Executive Session

COUNCIL MEMBER PRESTON MOVED, SECONDED BY COUNCIL MEMBER SMITH TO ADJOURN TO EXECUTIVE SESSION TO DISCUSS PERSONNEL MATTERS. THE MOTION PASSED UNANIMOUSLY, (9-0).

Mayor Joseph L. Nassif called the meeting back into regular session at 7:50 p.m.

COUNCIL MEMBER KAWALEC MOVED, SECONDED BY COUNCIL MEMBER HOWES TO APPOINT RALPH KARPINOS TOWN ATTORNEY WITH A STARTING SALARY OF \$40,000 PER YEAR. THE MOTION PASSED UNANIMOUSLY, (9-0).

Council Member Kawalec said Mr. Karpinos was currently working as an Assitant City Attorney for the city of Winston-Salem, where he has been employed for the past seven years.

South Columbia - Pittsboro St. One-Way Pair

Council Member Thorpe asked the Mayor not to forget to write a letter to NCDOT reaffirming the Council's desire to have the traffic signal at McCauley and Pittsboro be included in the new signalization system.

Ordinance 85-0-42 was on the floor for a second reading.

THE MOTION PASSED, (6-3) WITH COUNCIL MEMBERS PASQUINI, PRESTON AND THORPE VOTING AGAINST.

The ordinance, as adopted, reads as follows:

AN ORDINANCE AMENDING CHAPTER 21 OF THE CODE OF ORDINANCES (85-0- 42)

BE IT ORDAINED by the Council of the Town of Chapel Hill:

SECTION I

That Section 21-6 of the Town Code of Ordinances, "Trucks" is amended by deleting the following therein.

(b) It shall be unlawful to operate an automobile truck on Pittsboro Street between Cameron Avenue and South Columbia Street except local delivery trucks used in making deliveries to or from houses located in said area, it being the intent and purpose of this subsection to close Pittsboro Street, between Cameron Avenue and South Columbia Street, to use and operation by through trucks and by trucks not engaged in making deliveries to or from houses located within said area.

SECTION II

That Section 21-8 of the Town Code of Ordinances, "Traffic Control Signals" is amended by inserting the following therein, in appropriate alphabetical order:

Cameron Avenue and Pittsboro Street

SECTION III

That Section 21-10 of the Town Code of Ordinances, "One-Way Streets," is amended by inserting the following therein, in appropriate alphabetical order:

- (L) Traffic on South Columbia Street from Pittsboro Street to Cameron Street shall move only in a northerly direction.
- (M) Traffic on Pittsboro Street from Cameron Avenue to South Columbia Street shall move only in a southerly direction.

SECTION IV

That Section 21-13 of the Town Code of Ordinances, "Right-of-Way and Stop Regulations," is amended by deleting the following therein.

Through Street

Stop Street

Cameron Avenue

Pittsboro Street

SECTION V

That Section 21-27 of the Town Code of Ordinances, "No Parking as to Particular Streets" is amended by inserting the following therein, in appropriate alphabetical order:

Street	Side	From	<u>To</u>
Cameron Avenue	Both	Centerline of South Columbia Street	A point 630 feet west of Pittsboro Street
Pittsboro Street	Both	Cameron Avenue	South Columbia Street

SECTION VI

That Section 21-42 of the Town Code of Ordinances, "Establishing of Bikeways; Signs," is amended by inserting the following therein, in appropriate alphabetical order:

Pittsboro Street (west side) - from Cameron Avenue to a point 50 feet north of University Drive West Extension.

SECTION VII

These ordinances shall be effective at the time the N. C. Department of Transportation implements the one-way pairing of Pittsboro Street and South Columbia Street.

SECTION VIII

All ordinances and portions of ordinances in conflict herewith are hereby repealed.

This the 8th day of July, 1985.

Second reading July 15, 1985.

COUNCIL MEMBER SMITH MOVED, SECONDED BY COUNCIL MEMBER HOWES TO ADJOURN THE MEETING. THE MOTION PASSED UNANIMOUSLY, (9-0).
