Dear Ms. Kuschatka,

Since returning to live in an apartment community on Westminster Dr., Chapel Hill, NC (Timberlyne Apartments), I continue to observe two potentially unsafe areas in regards to transportation and safety of anyone directly involved.

The first area is the intersection of Banks Drive and Westminster Drive. Please review this area with someone with specific details for this would be very lengthy in this letter. There is a designated pedestrian crosswalk with ample signs approaching either direction of this intersection.

My concern is the volume of traffic entering this intersection everyday. There are many handicapped residents at Timberlyne Apartments, as well as those of us walking without transportation. Chapel Hill city bus service is on this route and now includes going down Westminster Dr. to 82 Magnolia, 100 Saluda Court (another large apartment complex) before turning to make an exit towards

town. The bus service now runs until close to midnight on most weekdays with the exception of holidays and of course, no service on Sundays. Other traffic includes school buses, private vehicles, and all other relative traffic in any town. Although the speed limit is posted at 25 MPH, there is excessive speeding every day. Another seemingly dangerous situation, some vehicles choose to pass slower cars; thus, creating another hazard to all traveling on this road.

Several of my neighbors have voiced concern over this intersection; i.e., would a four-way stop be appropriate for the safety of all concerned? This has been the most unanimous suggestion and most of the residents at Timberlyne Apartments would be willing to prepare a petition to further voice our concern.

The second issue is Westminster Drive. After resurfacing the asphalt approximately two years ago, the contractors never returned to paint the dividing line to designate two-lane traffic (from the intersection at Banks Dr. and extending all the way down through a residential neighborhood). Most of the residents feel that this is important to our safety since at dusk, in the evening, the visibility of everyone whether driving or walking is diminished. Some of us who live on the Westminster side of Timberlyne have actually heard the screeching of wheels and excessive speeding in this area.

Please take the time to drive through these areas and get a first-hand feeling as to the contents of this letter. If I can be of further assistance (by mail, phone, or petition), please do not hesitate to call me.




