### **Mason Farm Neighborhood Conservation District**

### Concept Plan: Belvedere Multi-Family Development

The Town has received a request for review of a Concept Plan Proposal for a multi-family development located at 2100 NC 54 East. The site is located on the north side of NC 54 East, approximately 1,200 feet east of East Barbee Chapel Road. The proposed project includes 84 dwelling units, comprising 145,000 square feet of floor area and approximately 144 parking spaces. Access to the site is proposed from NC 54 East. The 5.83-acre site is located in the Residential-1 (R-1) zoning district and the Resource Conservation District. The site is located in Durham County and is identified as Durham County Parcel Identifier Number 9798-04-94-5193.

### **Land Use Management Ordinance Text Amendments**

### Inclusionary Zoning Ordinance

A text amendment is proposed to the Land Use Management Or consider adding an Inclusionary Zoning Ordinance. The proposed rdinance would apply to all develop that creates five or more new dwo in gunits including subdivisions of five or more new lots, new multifamily dependence of five or more dwelling units, and redevelopments that add five or dwelling units. Units would be developed for households earning lepton than 80 percent of the area median income.



Bolin Creek Watershed Study – The towns of Carrboro and Chapel Hill have contracted with EarthTech, an environmental firm, to conduct field work along the Bolin Creek and its tributaries. The survey will identify problem areas of erosion, scour and polluted discharges, which will guide the towns in developing plans to enhance water quality and restore stream integrity. # Council To Consider Changes To Tree Protection Ordinance

Proposed changes to the Tree Protection Ordinance would establish a new vision statement that calls for no net loss of trees/canopy cover and an increase in trees proportional to population growth. Regulations could include a permitting process for tree removal with financial disincentives for unauthorized tree removal. One suggested change to the ordinance would require residents to receive permits to remove trees in a cumulative area more than 5,000 square feet (even if a building permit is not involved). A public hearing on these proposed changes is scheduled for 7 p.m. May 14 in the Council Chambers of Town Hall.

Turning on the light was made ceremonial by Mayor Kevin Foy, at far left, with principals Eileen Tully (Phillips) and Dale Minge (Estes Hills), teachers and students. The improvements were funded with sidewalk and street improvements bonds approved by voters in 2003 and earmarked for traffic calming and neighborhood pedestrian safety improvements. Many schools are working with Go! Chapel Hill Active Living By Design to encourage more students to walk to school.

### **Protecting Trees in Chapel Hill**

The Chapel Hill Town Council invites public input and discussion on proposed changes to the Tree Protection Ordinance at a public hearing set for 7 p.m. May 14 at Town Hall. Proposed changes would establish a new vision statement that calls for no net loss of trees/canopy cover and an increase in trees proportional to population growth. Regulations propose a permitting process for tree removal on private property, including residential.

The first step of the phased proposal would require a permit to remove trees in a cumulative area of more than 5,000 square feet. Changes are also proposed to lower the threshold size of trees that must be surveyed. The ordinance revision is linked to a commitment to sustainability with the potential to reduce carbon emissions and decrease the urban "heat island" effect. Information: 968-2728.
