Message sent by pomerantzphyllis@yahoo.com I note that staff are NOT recommending the downzoning of University Station to R-1 based on the moratorium going into effect for the Northern area and the establishent of the Northern Area Task Force.

Perhaps I am mistaken or there has been subsequent advice, but I believe I heard the town's attorney say that proposals that were already in the planning process (e.g., concept plan discussed by the Council) would not be subject to the moratorium. So it is not clear to me that University Station would be subject to the moratorium. I would appreciate a clarification of this point during tonight's council meeting.

Secondly, I would urge you to support the downzoning of the University Station property prior to the work of the task force. The Task Force will need to focus on broader vision questions and development guidelines. If specific proposals for University Station also become part of the Task Force's mandate, I fear that it will absorb too much of the Task Force's time and energy.

I urge you to support the immediate downzoning of the University Station property.
