Dear Mr. Neppalli,

Upon opening a mailing from the Town, I was delighted to read of the plan to erect a four-way stop sign at the intersection of Churchill Dr and LeClair St. I live on the corner of Churchill and LeClair, at 800 Churchill Dr., and have found this intersection to be dangerous. I find this area to be unsafe for drivers as well as pedestrians.

I spend a lot of time outside jogging, strolling with my baby, and rocking my baby on our front porch. This gives me plenty of opportunities to witness what is going on at the intersection and the excessive speed at which cars travel down Churchill. Crossing or turning onto Churchill from LeClair can pose quite a challenge as cars traveling on Churchill are usually exceeding the speed limit. In addition to all of the cars, both public school buses and the Chapel Hill Transit buses have the challenge of turning out into this intersection. I have been on the G Route a couple times when the bus did not see someone (probably speeding) traveling south on Churchill and pulled out in front of them, nearly causing an accident.

I am very concerned about pedestrian safety at the intersection and on the street. My husband and myself are avid joggers. We run in the evenings through the neighborhood and have a four month-old baby who joins us in a stroller. In the future, our baby will want to ride his bike on our road and I would like to feel safe about him doing so. In addition, there are children in the neighborhood that walk/ride bikes to the elementary school. While I think sidewalks and better lighting are also needed to improve pedestrian safety, better traffic control would be a great start. The stop signs that were erected at other intersections in the neighborhood seemingly have slowed down traffic (both thru-traffic and residents of the neighborhood) and made those areas safer to those of us walking, jogging, and playing in the street.

I hope that the plans to put up this new stop sign stay on course. I can't imagine why anyone in the neighborhood would object to such measures. I would hope that all residents of Briarcliff would want the neighborhood to be safe place to travel, live, and play.

We hope to make it to tomorrow's neighborhood meeting at Town Hall
