Re Endorsement and Support for Public Art 360

On behalf of the sponsors of *Public Art 360: A Symposium from Seven Perspectives*, we request endorsement and support from the Town of Chapel Hill for this multi-state convening about public art.

Public Art 360: A Symposium from Seven Perspectives

Public Art 360: A Symposium from Seven Perspectives is a multi-state convening that will be held 11 April 2008 - 12 April 2008 at Hanes Auditorium on the campus of UNC-Chapel Hill. The Symposium will address the functional and aesthetic interaction among public art, professional design disciplines, private development, and government. Nationally and internationally recognized speakers will explore the inherent complexities in public art from the perspectives of artist, architect, landscape designer, government, private developer, community, and critic. Sessions will frame critical issues associated with how public art projects are initiated, approved, funded, and implemented; how to reinforce shared objectives through public review; and, implications for public policy. Each of seven keynote sessions will represent an affiliated field; sessions are designed to be between 90 minutes and 120 minutes. Throughout the Symposium we will encourage dialogue among participants and speakers.

Context

Four hundred public art programs across America and hundreds of regional organizations are developing legal policies and public procedures to commission works of public art in their communities; many groups are exploring percent for art ordinances, which allocate a percentage of a capital project budget for an artist and/or work of art. Across the Southeastern United States, there is a pressing need to educate organizations, elected officials, the public, and design professionals about inventive responses to bring the work of artists into our experience of built and natural environments. There is also a critical want to develop public art policies and procedures that recognize the sometimes conflicting perspectives among artists, the owner of the project site, the source of funds, and public perception and evaluation of art in public space. In North Carolina, there are dozens of communities exploring how public art can become integral to municipal planning, streetscape design, cultural arts programming, and the commissioning and/or acquisition of specific works of public art. Public art in private development is a notably salient priority to both emergent and established public art programs across the State.

In February 2005, the Town Council endorsed and supported a public art lecture by Ron Fleming of The Townscape Institute, which initiated a larger discussion about public art in Chapel Hill. Since then, many of us (including the sponsors of Public Art 360) have met formally and informally to advance the reception of public art across the southeastern states: Public Art 360 is the outcome of these deliberations.

Symposium Details

Public Art 360 will draw approximately 250 arts professionals, students, and the public from multiple disciplines to address current and future orientations on public art through the perspectives of architecture; landscape architecture and design; artist; government; private development; critical scholarship; and the community. Program information is being distributed to allied professional design organizations such as the AIA, the ASLA, and the American Planning Association; the US Conference of Mayors and the Association of County Commissioners; universities; public art programs; arts funding agencies; municipal and county governments; and foundations and private developers. Attendees are expected to come from North Carolina, South Carolina, Washington DC, Maryland, and Virginia.

Public Art 360 is being organized by the Percent for Art Collaborative, North Carolina Arts Council, South Carolina Arts Commission, and the Orange County Arts Commission; its sponsors also include the Southern Arts Federation, Americans for the Arts Public Art Network, University of North Carolina-Chapel Hill, and Forecast Public Artworks.

Sponsorship of the symposium includes live links to the sponsor's website for a year as we will maintain the Symposium website to post updates prior to the event and conference proceedings and photographs following the convening. Interest has been expressed in conducting a live blog throughout the two days. The Town of Chapel Hill, a leader in public art, will gain broader and national recognition as we announce the event to professional organizations and artists noted above as well as offer opportunities for the display of program information. Finally, we hope the Town will find this event educational and see the benefits of supporting a strong outreach and communications project that enhances our collective understanding of public art.

Each of seven keynote discussions will frame critical issues associated with how public art projects can be initiated, approved, funded, and implemented, how to reinforce shared objectives through a public review process, and implications for public policy.
