### Requests:

- 1. The attached petition from the residents of Culbreth Ridge Homeowners Association (CHRA) requests that the Town of Chapel Hill conduct a comprehensive traffic survey to document the excessive speed and volume in the neighborhood. This survey is needed as the first step in the development of a comprehensive and improved system to manage traffic safety on our streets. CHRA would like this traffic survey to be done within the next 30 days. We would also like to request that the traffic survey is not conducted during a school holiday or a delayed opening day for CHCCS.
- Based on the traffic survey results, please implement the appropriate traffic calming tactics (e.g. add speed humps, diverters, chicanes, etc.) as necessary to reduce traffic speed and volume commensurate with the poor line of sight, high child pedestrian traffic and excessive vehicle volumes and speed.
- 3. Prior to the survey and tactical implementation, please designate Gar dner Circle and Hanser Court as an official school zone and lower the speed limits on these streets to 20 miles per hour. Our development is adjacent to Culbreth Middle School and serves as a pedestrian route for many local children from our own subdivision, as well as, Cobble Ridge, Kent Woodlands and Southern Village, and it has also become an unofficial "Kiss and Go" hub to deliver children to the school.
- 4. Please have the police implement a more frequent and systematic schedule of traffic patrol in our neighborhood. This is needed to enforce the speed limits, stop signs and other existing traffic controls that are consistently ignored by drivers passing through our streets.

#### **Background & Justification:**

The excessive traffic volume and vehicle speed combine with the blind curve topography of Gardner Circle to create a huge safety hazard to the residents of Culbreth Ridge Development and to the children who pass through our neighborhood on their way to Culbreth Middle School.

We have had incidents where mail boxes were knocked down and where side-view mirrors have been ripped from cars by vehicles speeding through our streets. Over time, the number of vehicles has increased significantly as has the speed of these vehicles. Additionally, drivers seem to pay less attention to the road ahead and the dangers they are creating.

If something is not done to modify driver behavior, it is certain that bodily injury and/or fatalities will result from this confluence of excessive vehicle speed, high traffic volume and poor driver visibility.

We want to work with the Town of Chapel Hill to develop and implement a traffic calming plan that improves the safety and efficiency of traffic flow in the Culbreth Ridge Development.

# Traffic Calming Needs Discussion: Culbreth Ridge Homeowners Assoc. (CRHA) and Town of Chapel Hill (TCH)

Meeting Purpose: Establish a dialogue between CRHA and the TCH Traffic Department leading to implementation of a traffic calming plan that improves the safety and efficiency of traffic flow in the Culbreth Ridge Development.

### **Discussion Topics:**

- Historical review & current needs justification for changes in the current traffic management situation - CRHA & TCH perspectives.
- 2. Specific short-term tactical requests CRHA:
  - a. Intersection of Gardner Circle & Weyer stop sign for right turn from Gardner onto Weyer needs to be moved closer to the road. Now it is behind a tree and not currently visible.
  - b. Gardner/Weyer intersection also needs a crosswalk painted across Weyer to connect the 2 handicap access ramps in the sidewalks.
  - c. The "No Outlet/Dead End" sign for Weyer Dr. cul de sac needs to be moved closer to the intersection at the Gardner/Weyer. Currently, it is difficult to see and not effective to prevent mistaken turns that way.
  - d. General review of all signs in the development vs. their current location and effectiveness. Many are not installed on the strip between the sidewalk and the road. Also, some are not angled to be perpendicular to the road. Adjustments to location and angle would improve visibility.
  - e. Current height of the Culbreth Ridge speed "humps" should be increased to match the ones on the main road through The Oaks. Ours are "raised cross-walk" height, not <u>full speed hump</u> height.
  - f. TCH feedback on go/no go and timelines for addressing these requests.
- 3. Longer-term traffic safety and calming plan development CRHA & TCH:
  - a. Many of CRHA's original traffic safety concerns (expressed in previous meetings) for vehicle speed, traffic volume and poor driver visibility have not changed or actually gotten worse. <u>CHRA would like work with TCH to develop a comprehensive traffic calming and safety plan for our development with the TCH.</u>
  - b. The attached CRHA petition is a request for TCH to conduct a traffic survey as the first step in the development of an improved traffic calming plan. CHRA also requests that this traffic survey be done within the next 30 days.
  - c. Need TCH comments/feedback on:
    - i. Timelines for implementation of the traffic survey
    - ii. The overall process, THC requirements and timelines for the development of an improved traffic safety/calming plan for CRH.
    - iii. Outlining the specific tactical traffic calming options approved for use in the TCH. What survey results would be necessary to justify the implementation of each specific tactic (e.g. adding a 3<sup>rd</sup> speed hump would require observing that average speeds to exceed 30 MPH for any 1 hour window during the survey evaluations)?
- Other topics, next steps and wrap-up.
  - a. Culbreth Middle School proximity "Kiss N' Go" lane and sports event parking lot volume
  - b. Can Culbreth Ridge zoned as a school zone?
