Lots 1, 2 and 3, identified as Tax Map and Pin Number (respectively): 7.18..16A/ 9870-87-1493; 7.18..16/ 9870-87-5224; 7.18..15/ 9870-97-1299, situate in Chapel Hill Township, Orange County, N.C., and more particularly described as follows:

Beginning at a new iron rod, on the southern right-of-way line of Eubanks Road (SR 1727), thence with said right-of-way the following courses and distances:

N 84º12'47" E, 83.41 feet to a point,

- thence a curve to the right with a radius of 1,041.12 feet, a curve length of 301.31 feet, chord bearings N 88°51'25" E, 168.58 feet and S 82°51'08" E, 132.45 feet,

Thence with Jacqueline Upperman, N 04°11'37" E, 968.20 feet to a new iron rod on the southern right-of-way line of Eubanks Road, the point and place of beginning, and containing 33.757 acres more or less.
