Thank you for your thoughtful responses to the UNC proposal last night.

continue to believe that if you must decide on the whole application by July 5, the responsible response is no. I wish the mayor luck in getting satisfactory answers from the chancellor.

Here's one further comment about the issue I raised last night regarding the lack of a road out to Manning from the student housing complex. There's a long and happy history of Glenwood Elementary's being the school for the children who live in UNC's student family housing. Along with their graduate student parents, they are a transient population, but they're consistent in being largely an international community. Over the years, Glenwood has risen to the challenge of meeting the needs of these children. That challenge has reaped many rewards in the form of the unique kind of energy and diversity that these children bring to the lives of the more typical American students and staff at Glenwood.

If getting there becomes as hard as it will under UNC's proposed plan, I can imagine a time when the school district will want to redistrict this area—say to Scroggs or Frank Porter Graham, either of which would be more convenient in terms of traffic flow (although farther away). After years and years of a stable, mutually supportive relationship between Glenwood and this UNC community, minor havoc could be wreaked because of one ill-considered planning decision. This unintended consequence ought to be recognized and avoided.



This issue is an example of the ongoing need to pay attention to cases where the imperatives of the town and those of the school system intersect—or threaten to collide. On that subject, I thank you for item #4s on your consent agenda last night, which will begin a conversation on the reservation of school sites.

The Town Clerk recommended that I request that Mr. Waldon amend his memo, to include lifting the water/sewer restriction for Northwood. Per the Town Clerk, she stated that if the memo can be changed prior to distribution on Wed of this week (she predicted Wed would be the final day for this type of request to edit the proposal), Northwood would be in a better position when the Council meets on 6/23 to address this issue.

Could you distribute to council members? I'm getting a few of these addressed only to me, but I think they should be given to everyone.

Dear Dorothy,

I have followed your work in town and on campus concerning pedestrian safety for the past five years, in the Glen Lennox school crossing, on Manning Drive following the fatality there, and in your leadership as a faculty member to form a committee and create crosswalks between the UNION and SRC to ensure the safety of pedestrians on campus. I was very pleased when you were elected to the Town Council and for this reason I am writing specifically to you concerning the increased danger to pedestrians and UNC students that will come with the University's proposal to construct the 600 -car Cemetery Parking Deck.

My husband and I who live at 737 Gimghoul Road, attended the entire public hearing last Monday concerning the University's Application to amend its development plan. Dale, Professor of City and Regional Planning and Professor in the School of Public Health, spoke about how the increase of 300 spaces at that already dangerous crossing will result in many more cars cutting through Gimghoul Road and exiting onto Raleigh Road--54 to avoid the jam up that will result at the intersections of Country Club and South Rd. and Cemetery Parking Deck Lane. It was obvious at the meeting that the University's consultants did not even know about the outlet that exists through the old St. Thomas More Church on Gimghoul, even though Jonathan Howes has used it himself. The entrance to that large series of old church parking lots is across the street from our house. In addition, the Catholic Diocese of Raleigh rents out a couple hundred parking spaces in these former church lots to students and employees of the University, who each morning and evening walk down Gimghoul to and from campus. Throughout the day students and faculty jog on our mile neighborhood loop and it is not unusual to see entire Physical

Education classes pass by. And yet there was no mention in the University's Application before the Town Council of proposed measures to protect the safety of these pedestrians crossing Country Club. It was obvious that the University had not done an assessment of the number of UNC pedestrians and employees using Gimghoul to access the university both for work and recreation. The Gimghoul Historic District Neighborhood is THE unofficial park of Chapel Hill, but there are no sidewalks on Gimghoul, and the joggers, elderly folk, baby-strollers, dog-walkers and the Twin Sisters' Garden open to the public all use the street.

Some of my neighbors spoke at the June 16th public meeting about their concerns about the neighborhood being cut off from safe access to campus and increased traffic in our neighborhood. Other town citizens spoke eloquently about the wisdom of bringing more cars to the most beautiful heart of campus. But I want to speak with you about the very real possibility that a serious injury or fatality will occur as a result of increased traffic crammed into this pedestrian area.

Five years ago I was the victim of a hit and run accident in which my leg was severed and amputated. I now wear an artificial leg. I suppose because of this I am more sensitive to the everyday reality

that accidents happen, and that people are maimed for life or die in a split second encounter with a motor vehicle. Living directly behind me in our neighborhood is Professor Emeritus John Schutz of the Religion Department who was hit by a car while riding his bike in town and suffered brain damage which cut short his career as a university professor. I see John and his wife often holding arms walking around the block, as my husband and I do. There isn't much you can do to undo the damage we have suffered, but there are so many bright, active people you can protect.

Dear Mr. Mayor and Council Members:

Having expressed, as a member of the T-Board, some of my concerns about the UNC development plan and having sat through all of last evening's public hearing I would now like to share with you some additional thoughts and concerns regarding the University's plans.

- 1. The University representatives repeatedly made the point that the Master Plan will provide an additional 10 acres of green space to the campus through elimination of surface parking and replacement of surface parking with parking decks. However, they do not highlight the fact that the Master Plan provides for an additional 1500 parking spaces on campus (beyond what is there now). Thus there may be more green space to walk and ride on campus (depending on how this newly-created green space is developed) but it may potentially be negated by the >3000 vehicular trips/day that their Master Plan will generate, most of these trips occurring on the central campus.
- 2. The University representatives seem to put a significant premium on providing proximal parking to the employees. They repeatedly pointed out that all of the decks under discussion last night are on the Master Plan. Even though they define the Manning deck (the one they propose to eliminate) as proximal, it is still on the periphery of today's campus. If the University is truly committed to providing a pedestrian and cyclist friendly campus they should be willing to build the furthermost decks first. Later, if additional parking needs can be demonstrated, they could build additional decks on the interior of the campus. Such a policy would serve two purposes: it would lessen, at least for the immediate future, the vehicular traffic on the central campus and it would give the University an opportunity to "educate" their employees regarding the benefits of parki! ng on the periphery. This "education" could include financial incentives to the employees such as suggested by Heidi Perry in her recent memo. It would hopefully include the increased quality of life on campus resulting from reduced vehicular traffic (i.e., employees might be able to traverse the campus without fear for their safety and well-being as was described by a faculty member last evening).

One last note: it was interesting to me that no one at last evening's meeting asked what the students might want or what is in the best interest of the students. Although sometimes it may be easy to think of the students as a "transient" citizen population, their quality of life and safety while they are here should be as important as that of the employees of the University and the other citizens of Chapel Hill. I would be very surprised if additional parking decks on central campus are high on the students' current priority list.

The Clerk also mentioned that this issue may not be eligible for modification under State statute, requiring a public hearing, and that the Council may not be able to do anything until such time. Again, given the reasons submitted from our many emails, we would request that anything that can be done to alleviate this negative impact, be done immediately, to allow the residents to proceed on our improvements in progress, Given that the Council has indicated that the current impact of the ordinance on Northwood was not the intent, we hope for a reasonable and expedient solution.

Ladies and Gentlemen:

I ask that this letter be distributed to members of the Town Council and that it be made part of the record of the Council¹s public hearing tomorrow evening regarding the University¹s request for a modification of its campus master plan. As you know from my earlier letter, my wife and I own family graves in the cemetery itself.

When I first learned of the University¹s proposed plan modification, I characterized it as a ³wanton act of vandalism² insofar as the cemetery is concerned.

wish to apologize to the Chancellor and Vice Chancellor. The word ³wanton² implies a deliberate intention to do harm. Upon reflection, I think no harm was intended, and that while the present proposal does have some highly undesirable impacts, with good will on the part of the town and the university and a bit of give and take on both sides, some of these impacts can be minimized.

The public hearing before the planning board last week was a special disappointment. I sensed that both sides were playing defense, which is a no-win situation. I was disappointed that much of the discussion centered on quantitative issues of marginal importance -- on numbers, if you will -- with relatively little attention to the qualitative aspects of the project.

Our present planning processes to not emphasize these design and cultural issues. While it is the council¹s decision to make, I would urge you in spite of the time constraints you face to give special consideration to the views of the Historic District and Community Design Commissions, neither of which appears to have been specially consulted. To do so may also positively address in advance some of the concerns that the North Carolina Historical Commission will undoubtedly have in its required review of the project under G.S. 121-12(a).

With special attention to reducing the footprint of the parking deck, perhaps by re-orienting it, and having special sensitivity to the issues of color, texture, apparent scale, and landscaping of the south-facing façade of the deck, some of the more harmful impacts on the cemetery as seen from South Road and within the cemetery may be reduced. The wintertime view of the project from South Road is critical. I am confident that the University's highly competent design professionals are very sensitive to these and related issues and will make every attempt to resolve them.

Special attention to operational details during and after construction, such as noise during the occasional funeral, the operation of the chiller, and lighting will also be important.

I continue to believe that to concentrate automobile parking with its attendant pollution so close to the cemetery can and will be especially harmful to its gravestones and monuments and to the cemetery as a whole, given the level of air pollution in the Triangle. It is also hard to imagine that the view from the windows of the five surrounding dormitories and the operation of a parking deck will be pleasing to the students who occupy them. I believe a better solution would be to locate a larger parking deck at the visitors lot on South Road, perhaps supplemented with a frequent jitney service to locations that would otherwise be serviced by yet another on-campus deck, as well as special attention to the impact of such a deck on the nearby Gimghoul Historic District.
