

# Annexation Petition






To the Town Council of the Town of Chapel Hill:

1. We the undersigned owners of real property respectfully request that the area described in paragraph 2 below be annexed to the Town of Chapel Hill, consistent with § 160A-58.1. of the statutes of North Carolina.
2. The area to be annexed:
  - o is not contiguous to the Town of Chapel Hill, but
  - o is contiguous to another area that may simultaneously petition to also be annexed to the Town of Chapel Hill
 and the boundaries of such territory are as follows:

Beginning at a point located at the southwestern intersection of Rogers Road and Tallyho Trail, thence from said beginning point along and with the western side of Rogers Road south 10 ° 24 ' 35 " east 241.85 feet to a point; thence continuing with the western side of said Rogers Road south 10 ° 30 ' 14 " east 274.30 to a point; thence continuing with the western side of said Rogers Road south 10 ° 46 ' 43 " east 130.49 feet to a point in the line of now or formerly Charter Development; thence with the northern lines of n/f Charter Development, n/f Pika Developers, n/f John D. Denuzzio, n/f David Ravenscraft, n/f Hal J. Chapel and n/f Robert Connolly south 89 ° 07 ' 40 " west 822.61 feet to a point, a corner of n/f Tina L. Magyar in the line of n/f Connolly; thence with the eastern lines of n/f Magyar, n/f Mary F. Kerr, n/f George V. Plughoft and n/f James C. Linn north 01 ° 39 ' 38 " east 738.88 feet to a point in the southern side of Tallyho Trail; thence with the southern side of said Tallyho Trail south 82 ° 22 ' 29 " east 187.45 feet to a point; thence continuing with the southern side of said Tallyho Trail south 82 ° 33 ' 32 " east 189.58 feet to a point; thence continuing with the southern side of said Tallyho Trail south 82 ° 33 ' 15 " east 201.08 feet to a point; thence continuing with the southern side of said Tallyho Trail south 82 ° 18 ' 56 " east 110.84 feet to the southwestern intersection of Tallyho Trail and Rogers Road, the point and place of beginning, containing 11.826 acres, more or less.

This area is more commonly known as the Highland Meadows Subdivision, as recorded on the Plat Map in Book 61, Page 126 of the Orange County Registrar of Deeds.
