

# PETITION REQUESTING VOLUNTARY ANNEXATION

Executed as effective October 1, 2004

To Mayor Foy and the Town Council of Chapel Hill:

1. We, the respectively noted owners of real property constituting the whole of the subdivision known as the Highlands in Orange County, North Carolina ("the Highlands"), being located generally at the northwest corner of Rogers Road and Homestead Road, respectfully request that the area referenced in paragraph 3 be annexed into the Town of Chapel Hill ("Town") effective January 1, 2006, or sooner if required by law.
2. We ask that these properties constituting the Highlands be annexed into the Town with our present infrastructure (*i.e.*, existing road layout and connections, absence of street lighting, uses of green stormwater swales, absence of sidewalk, and the like) not being modified in the future.
3. The area to be annexed is located in Orange County, is contiguous to the planning area of the Town, is fully developed with a total assessment base of \$31 million (FY2004), is served by the Orange Water and Sewer Authority, and can easily be provided municipal services by the Town, is illustrated in the attached Highlands Subdivision Map, and is further described by language and illustrated by maps in attached Schedules A through C.

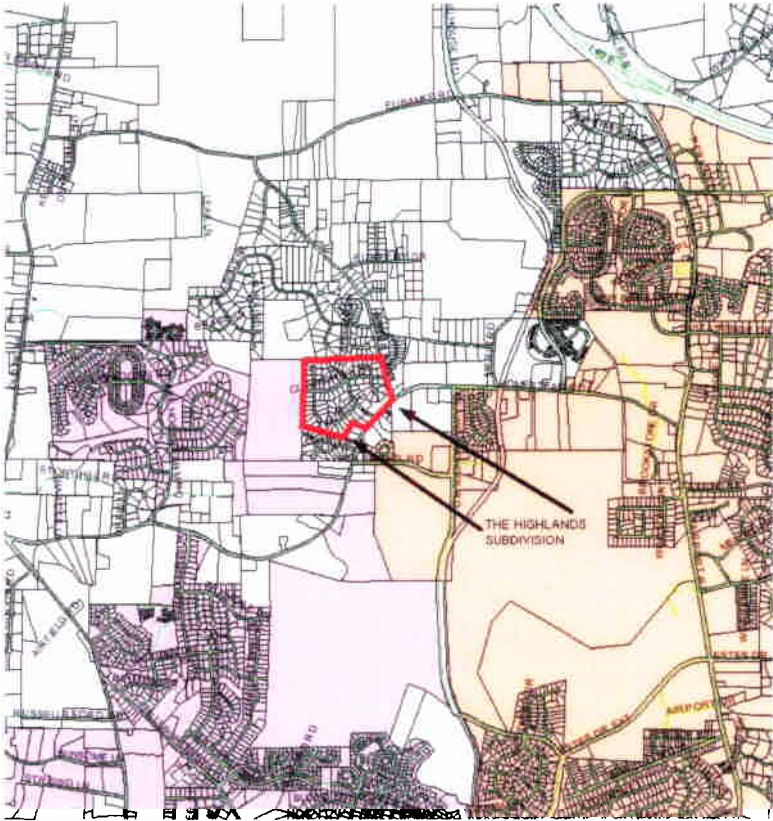
