- The per capita cost of service for each department was calculated by dividing the 2004-2005 adopted budget for each department/service listed. For example Planning \$1,112,087 divided by 51,485 (2003 State certified population estimate) equals \$21.6/capita.
- Vineyard Square estimated population Year 1 = 246 persons.
- Larkspur estimated population Year 1 = 78 persons.
- We estimate that the Town population Year 1 would increase by 324 persons as a result of these annexations which is an increase of 0.63%.
- We note that for 10 of the last 14 years the number of single family units authorized in Chapel Hill has stayed within the range of 200-400 units per year. Assuming these units are occupied at the same rate of 2.3 persons per household as recorded for the Town in the 2000 Census. The Town population can be estimated to rise by 460 to 920 persons per year, exclusive of population added as the result of annexation.
- The average annual population change in Chapel Hill since 1990 is 2.2%.
