Dear City Council Members:

Please find attached a petition entitled "PETITION TO ABOLISH RESIDENTIAL HOMEOWNERS PORTION OF BUSES SERVING "V ROUTE" CHAPEL HILL TRANSIT." The attachment includes a true and accurate copy of all original signature pages. A copy of the enclosed has also been submitted to Mary Lou Kuschatka, Director Transportation Services, City of Chapel Hill Transit; Graham Dych, Board President of Southern Village; and, John Lawton, HRW Homeowners Association Representative for Southern Village. We have also had one informal meeting with Mary Lou Kuschatka where we were informed that she would attempt to initiate by mid-October a City Council hearing concerning the relief requested in our petition.

As set forth in the petition, we respectfully seek immediate consideration for relief and redress. Should you have the authority to grant the requested relief, alone or in combination with the other petitioned parties, we request such relief. Should, however, a hearing be necessary and appropriate, we respectfully request such hearing as soon as possible to avoid any unnecessary delay. As you may know, the City of Chapel Hill Transit and Transportation Services has a deadline of sometime in late October 2001 to discontinue, abolish, reevaluate and/or re-route the present bus and transit services.

We respectfully contend that the results of this petition drive overwhelmingly support (1) abolishing all transit bus and public transportation services to the entire *homeowner residential area* of Southern Village and (2) prohibiting all *non-resident commuter parking* in the entire homeowner residential area of Southern Village. We further petition that all signage relating to any and all "Bus Stops" in the homeowner residential area of Southern Village be removed.

As set forth in the attached "Tabulation" of the results of this petition, attempts were made to personally contact (nearly all door-by-door) on at least one occasion 98% of the occupied residential homeowner households. Moreover, an impressive and statistically significant representation (approximately 61%) of the total occupied residential

homeowner households that were successfully contacted had a position respecting the petition, i.e., the household signed in support of the petition or opposed the petition.

Of the households that were successfully contacted, and a position (i.e., signed in favor of the petition or declined to sign opposing the petition) was taken by a resident of such household, an overwhelming 87% signed the petition in favor of the matters set forth therein. The number of occupants residing in households signing in favor of the petition was a staggering 845 individuals. Unfortunately, 216 residential households were not successfully contacted, however, we submit that the percentages would not vary because the 61% successfully contacted is more than statistically significant.

In fact, in prorating the tabulations to include the unsuccessfully contacted households, a staggering 493 households support the petition ($305 + .87(216)$) and an overwhelming 1484 households residents ($845 + (.87)(216)$) ($845/305$) support the petition.


Thus, we respectfully submit that these petition results more than adequately demonstrate that an overwhelming percentage and number of Southern Village homeowner residents want all public transportation and all non-resident commuter parking re-routed from the homeowner residential portion of Southern Village to the Park & Ride area. We, however, recognize that some fully appropriate public transportation may need to be provided to the homeowner residential area, such as that mandated by State or Federal Law, such as, for example, handicap-assisted van pools.

We further respectfully acknowledge that transit bus or other public transportation to the long-established Park & Ride area in the commercial portion of Southern Village has been purposely excluded from this petition. Hence, any relief and redress granted in response to this petition would in no way affect bus or other transit service or commuter parking in the commercially designated Park & Ride portion of Southern Village.

Also, in moving forward with other issues (e.g., reducing the speed of vehicles in Southern Village), concerns (e.g., the need for a traffic light at Arlen Park Drive and 15/501) and prospective developments (e.g., development of the commercial area in Southern Village) within and affecting Southern Village, we would respectfully request that public hearings/meetings be scheduled, and that the homeowners be notified, invited and encouraged to attend such hearings. We firmly believe that by encouraging communication, all concerned parties will all benefit and Southern Village will thrive and continue to be a valuable asset to the City of Chapel Hill.

**PETITION TO ABOLISH RESIDENTIAL HOMEOWNER PORTION OF
BUSES SERVING "V ROUTE" CHAPEL HILL TRANSIT**

What Is Petitioned

WE, the homeowner residents of Southern Village by signature herein, respectfully petition the City of Chapel Hill, Chapel Hill Transit, the governing Board of Southern Village and its members, and HRW, Inc. to abolish bus transit service to any and all paved roads within the homeowner residential area of Southern Village, including but not limited to the "V Route" promulgated by Chapel Hill Transit.

WE further respectfully petition, alternatively and collectively, the City of Chapel Hill, Chapel Hill Transit, the governing Board of Southern Village and its members, and HRW, Inc. take any reasonable and legal means to diligently and continuously ensure, to a reasonably achievable degree, that no motor vehicles, being the responsibility of or under the control of, non-resident commuters utilizing the Southern Village Park & Ride area be permitted to park on paved roads within the homeowner's residential area of Southern Village.

If necessary and appropriate to grant relief, WE respectfully request a hearing with the City of Chapel Hill, Chapel Hill Transit, the governing Board of Southern Village, and HRW, Inc., individually and/or collectively, to seek redress and relief.

WE make this petition based, at least in part, on the following generalized concerns, including but not limited to:

- Unreasonable and unnecessary physical intrusion in terms of the *size* of the buses, the *number* of buses, the *timing*, *sight*, disruptive *sound*, *air quality* and pollution, bus *signs*, bus *stops* and the extreme *frequency* and *degree* thereof
- Unreasonable and unnecessary intrusion in view of the very low number of passengers, i.e., "ridership", and the close proximity to the Park & Ride Station in the non-residential portion of Southern Village, which would cause no undue burden to use
- Non-resident commuters parking on residential streets
- Security of the homes and streets of Southern Village
- Safety of the streets and sidewalks of Southern Village
- Potential to at least modestly reduce homeowner's property values

What Is Not Petitioned

This petition, of course, does not apply to any motor vehicles, publicly or privately operated, not expressly referred to in this petition, such as (but not exhaustively listed) construction related vehicles; U.S. Postal vehicles; privately operated mail carriers; Fire, Police and other government-related vehicles, vehicles of guest's of residents; privately and publicly operated refuse and garbage removal/recycling service vehicles; publicly and privately operated delivery vehicles; and, any and all other publicly or privately operated vehicles delivering or servicing the needs of the residential community.



