Dear Mayor Waldorf and Council Members,

I recently learned that some members of the Southern Village community hope to eliminate the V bus route from Chapel Hill Transit service. After a moment of disbelief, I became concerned that this wish might become reality.

Many fellow law students, other students, and campus employees take advantage of the V bus, which runs in a loop among Southern Village, the UNC campus, and Meadowmont. In recent weeks, I've asked others about their support for the V bus and public transportation. Enclosed you'll find the signatures of 120 people who hope the bus will continue to run.

As leaders of this community, I feel confident that you will stand strong in your support of public transportation. More than just a convenience and an economic solution, buses improve the quality of our air by allowing thousands of riders to leave their cars at home each day. Our buses are driven by highly trained members of the community and keep hurried motorists off the streets, protecting pedestrians and children.

If the V bus or any other route can be stopped because some people believe it doesn't fit into a middle class lifestyle, are we promoting public transportation, standing up for our environment, and protecting children? I don't think so, and the many others who have pledged their support agree with me. Please take this into consideration during any discussions about the V bus or other public transportation issues.

In addition to the petition my friends and I circulated (entitled Keep the V Bus Running!), you'll find enclosed another compilation of about 30 signatures gathered by Robert Koontz, a concerned Southern Village resident.
