

Dear Sirs:

I am petitioning the town council to place a stop sign at the intersection of Old Oxford Rd. and Ridgecrest Dr. A three-way stop currently exists at the intersection.

I live at 200 Ridgecrest Dr., at the corner of Ridgecrest Dr. and Old Oxford Rd., and have frequently observed vehicles driving at speeds exceeding the posted twenty-five mile-per-hour speed limit, while traveling straight through the intersection or turning left onto Ridgecrest Dr., into the Lake Forest Subdivision.

In the early morning hours of March 4th, a car, traveling too fast, lost control while turning left onto Ridgecrest Dr. and skidded into the drainage ditch at the edge of our property. Fortunately, no one was injured, but the car was not operable and had to be towed later that day.

The area surrounding the intersection is heavily populated with many pets, children playing and residents walking, jogging and biking. There are no sidewalks on Ridgecrest Dr., so pedestrians are forced to walk on the edge of the street. The left turn onto Ridgecrest Dr. is also partially obstructed by a wide island with trees, which may limit a driver's view of pedestrians.

The lack of a four-way stop poses a significant risk to pedestrians and speeding drivers alike. I urge the mayor and the town council to place a stop sign at this location as soon as possible. I have enclosed a petition of support signed by residents of the neighborhood.
