
Dear Mayor Foy,

This letter is to request the installation of speed bumps on Lonebrook Drive through the Parkside and Northwood subdivisions. Speed bumps are needed for the following reasons:

- Lonebrook Drive is a main artery within Parkside and Northwood subdivisions. It connects Weaver Dairy Road with New Parkside Drive. Weaver Dairy Road and New Parkside Drive are the main entry/exit points into our subdivisions. As such, Lonebrook Drive carries a significant amount of traffic frequently traveling above the posted speed limit.
- There are many school bus stops made along Lonebrook Drive. The addition of speed bumps would make it safer for children waiting along side Lonebrook Drive.
- Visibility is somewhat limited at streets intersecting Lonebrook Drive due to curves, hills, shrubs and cars parked on the street. There has already been one accident involving a car and a child on a bicycle at the intersection of Lonebrook Drive and Glenmore Road. Slowing traffic with speed bumps would allow drivers' more reaction time.
- At least two residents of Parkside subdivision have resorted to setting up orange cones in an attempt to slow traffic during times when children are playing. While only one of these is at an intersection with Lonebrook Drive, the addition of speed bumps on Lonebrook Drive would contribute to heightened safety awareness throughout the neighborhood.

Attached you will find a petition signed by my neighbors supporting the addition of speed bumps on Lonebrook Drive. Additional signatures can be obtained if they are needed.
