

December, 7, 1922,

The Board of Aldermen met at 7:15., Mayor Roberson presiding.

Aldermen present:-Andrews, Brawne, Cheek, Durham and Odum.

The minutes of last meeting were read and approved.

1-Mayor Roberson made a report for the Committee appointed to request financial aid from the State. The Committee presented to President Chase and to the Executive Committee of the Board of Trustees a petition for the State to give to the Town of Chapel Hill \$5,000, for the years 1923-'24 and 1924-'25 to be used for more adequate Police and Fire protection, for better maintenance of streets and sidewalks, and for better sanitary and Health conditions. The petition was very favorably accepted. The Committee is to present the same petition to the Budget Committee of the Board of Trustees on December 18th.

2-The Manager reported that the gutters for School-Walk had been put in at a total cost of \$203.14.

3-The Manager reported that the installation of the light for the School Walk would cost about \$30.00. On motion he was instructed to have this light put in.

4- Sewer, Rosemary Street.

On motion Alderman M. W. Durham, duly seconded by Alderman G. M. Brawne, the following resolution was adopted.

BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL:

Sect. 1. That a sewer line be constructed on Rosemary Street from it's intersection with Church St. to the manhole in hollow below residence of Mr. S. W. Andrews. and one manhole at intersection of Church and Rosemary.

PROVIDED THAT: There are as many as five applicants for sewer connection within area of 300 ft of said sewer line.

Sect. 2. That Bond Ordinance in usual form shall be passed when 5 applicants received.

Sect.3. Note to be issued and proceeds used for the said sewer line.

On motion Alderman Andrews, duly seconded by Alderman Cheek the following refunds of taxes were made;
1-Mrs Martha Neville \$5.65, error in listing property;
2-Edward Perry \$0.63, tax on lot not in town;
3-James Cobb \$3.44, tax on property not in town.

On motion of Alderman Odum, duly seconded by Alderman Cheek an appropriation of \$100.00 was made for the purpose of planting trees on the streets.

On motion Alderman Brawne, duly seconded by Alderman

Andrews, the Manager was allowed to do some maintenance work on the sidewalks and charge expenditures for same to the account "Maintenance of Streets."

On Motion Alderman Brawne, duly seconded by Alderman Andrews, an appropriation of \$82.50 was made for the purchase of a typewriter for Town Office.

On motion Alderman Cheek, duly seconded by Alderman Durham the resolution allowing Mr. J.P. Foister to repair and rent the Old Fire House was amended so as to allow Mr. Foister to pay 13 months rent in advance. In repair of building, Mr. Foister spent \$52.00 and he is hereby allowed to rent the building at the rate of \$4.00 per month until this amount is conserved---13 months.

On motion Alderman Odum, duly seconded by Alderman Cheek a resolution was adopted for the enlargement of the cemetery. A committee consisting of Alderman Odum and the Manager was appointed to take this matter up with the officials of the University, asking them for more land; and to make all surveys necessary.

Upon request of the Manager, a resolution was passed allowing him to make all necessary changes in the Street Sign System.

There being no further business the Board Adjourned.
