

July 27, 1922

The Board of Aldermen met at 8 P.M., Mayor Roberson presiding.

Aldermen present:- Andrews, Cheek and Pratt.

The minutes of the last meeting were read and approved.

On motion E.M.Knox was elected Business Manager for a period of one year ending June 14, 1923 with salary at \$1,290.00 for the year, and with the duties of Town Clerk, Town Tax Collector, and Purchasing Agent in addition to the regular duties of Business Manager.

Mr. M.C.S.Noble appeared before the board and made a talk in regard to Traffic Regulations.

A motion was made and passed that the Business Manager draw up and present to the Board for approval at its next meeting a complete set of traffic regulations. In this connection, the Business Manager was ordered to devise some suitable signal at the intersection of Franklin and Columbia Streets.

Mr. E.E.Peacock, public auditor, appeared before the Board and made a verbal report of his audit of the Town books. This audit was not entirely complete and was not accepted at this time.

A motion was made and passed that all fees collected in connection with State and Town warrents be deposited in the general fund of the Town Treasurer from this date henceforth.

Due to the fact that the automobile tags did not arrive on time, the period for the renewal of all Town Licenses was extended until September 1, 1922.

A motion was made and passed that one hydrant with a "steamer connection" be placed at the intersection of Henderson and North Streets, and that the Business Manager confer with the University Authorities in regard to a hydrant at the intersection of Henderson and Rosemary Streets.

A motion was made and passed that no streets shall be accepted by by the Town from this date unless they are surfaced and approved by the Business Manager.

There being no further business the Board adjourned.

August 3, 1922

The Board of Aldermen met at 8:30 P.M., Mayor Roberson presiding.

The Aldermen present were:- Messers. Andrews, Cheek and Durham.

The minutes of last meeting were read and approved.

A motion was made and passed that the following ordinances in regard to Traffic Regulation be adopted.

1. No driver shall allow persons to ride on the fenders or running-board of his automobile in a reckless manner.
2. No person shall make a left-hand turn without first giving the proper signal and satisfying himself that there are no vehicles approaching from the front or rear so as to cause danger of collision.
3. No automobile or horse drawn vehicle shall be parked within FIFTEEN FEET of a Fire Hydrant.
4. On that part of Franklin Street between Church Street and Raleigh Road, all drivers of automobiles shall go to a street corner to turn around, and shall do so then only after making the proper signal with his hand and horn.
5. All drivers of automobiles operating their cars at night shall dim the lights when meeting automobiles.
6. No person shall operate an automobile with any form of cut-out or with the plugs out of the muffler.
7. The right-of-way streets are FRANKLIN, ROSEMARY, AND CAMERON AVE., and all persons driving into these streets must drive slowly and exercise a great deal of caution.

On motion the Business Manager was instructed to order a fire hydrant placed at the intersection of Rosemary and Henderson Streets.

A motion was made and passed that the Organization Chart be accepted as shown in Book 3, page 229.

A motion was made and passed that the Estimated Expenditures for the municipal year ending May 31, 1923 be approved as shown in the Budget, Book 3, Page 230.

A motion was made and passed that the sum of \$200.00 be appropriated to the Fire Department to defray the expenses of the representatives sent to the State Firemen Convention.

A motion was made and passed that the Peoples Bank, Chapel Hill, N.C. be made the Treasurer of the of the Sewer and the Improvement Bond Issues, with the understanding that the sinking fund is to receive interest semi-annually at the rate of 6 per cent and that said Bank shall give a satisfactory bond to the amount of the fund in its hands.

A motion was made and passed that the Tax Collector be required to give a bond of \$5,000.00, and the fee is to be paid by the Town Treasurer.

A motion was made and passed that the License Tax on Private Automobiles be reduced from \$2.00 to \$1.00 for the year.

There being no further business the Board adjourned.

October 5, 1922

The Board of Aldermen met 8 P.M., Mayor Roberson presiding.

Aldermen present were,- Messers. Andrews, Cheek and Durham.

The minutes of the last meeting were read and approved.

Upon motion the resignation of Dr. Joseph Hyde Pratt was accepted, and the Clerk was instructed to write Dr. Pratt a letter of acknowledgement and thanks for his long and faithful services.

A motion was made and passed that Mr. G.M. Braune be appointed to fill the unexpired term of Dr. Pratt.

A motion was made and passed that Mr. H.W. Odum be appointed to complete the unexpired term of Mr. G.C. Pickard, resigning.

A motion was made and passed that the License Tax Schedule be amended so as to include a yearly License Tax for "Any Other Business" than those specially specified therein.

A motion was made and passed that the Bank of Chapel Hill be made the Treasurer of the Town; and the vouchers are to be signed by the Manager, approved by the Chairman of the Finance Committee and countersigned by the Mayor.

A motion was made and passed that Mr. W.B. Thompson be refunded the penalty he paid on his 1921 taxes because of a special understanding with the Mayor and the Treasurer due to the fact that the Town owed Mr. Thompson a large bill at the time his taxes were due.

A motion was made and passed that the Manager be instructed to trade in the old truck to the Stroud Motor Co. for a new Ford truck, and the Budget allowance of \$300. for a tractor be used in part payment of the new truck, the balance due to come from the Contingent Fund.

A motion was made and passed that the old Fire House at the intersection of Franklin and Columbia Streets be repaired at a cost not to exceed \$50.; and that Mr. J.P. Foister be allowed to rent this house at the rate of \$4. per month, six months rent to be paid in advance. PROVIDED, THAT in case the Board of Aldermen desired to move this building at any time, they have the privilege of refunding Mr. Foister any rent he may have paid in advance at that time.

A motion was made and passed that Section 22 of the Sanitary Ordinances be repealed.

A motion was made and passed that the Town borrow from the Bank of Chapel Hill \$1000. for a period of 30 days to defray the expenses of the current month, the note to be negotiated by the Mayor and attested by the Clerk.

There being no further business the Board adjourned.
