Section 2. That the Manager is instructed to prepare a petition for the widening of the transfer portion of this street and circulate it among the property owners for their signatures.

Section 3. That the Board of Aldermen will meet in special session one week from today, the same being Thursday, June 11, at 4:00 P.M. for the purpose of receiving the report from the Manager. #The Clerk made the following certificates of sufficiency for the construction of concrete curbs and gutters on Roberson and McCauley Streets:

Upon the motion of Alderman C.L.Wills, seconded by Alderman C.T.Durham the meeting adjourned at 6:15 P.M.

There was a meeting of the Board of Aldermen of the Town of Chapel Hill at 4;00 P.M., Mayor Roberson presiding. The Alderman present were Messrs. G.M. Braune, C.T. Durham, M.E. Hogan, B.S. Williams, and C.L. Wills.

The Manager reported that he had circulated among the property owners a petition to the Board of Aldermen asking that the curbs be moved and the street portion of Franklin Street be widened between Henderson and Columbia Streets; that less than 51 percent of the property owners had signed the said petition; and that the said petition was not sufficient. And upon motion of Alderman M. E. Hogan, seconded by Alderman C.T.Durham, the following resolution was duly passed, all the Aldermen present voting in the affirmative therefor.

Be It Resolved By The Board Of Aldermen Of The Town of Chapel Hill.

Section 1. Whereas the petition from the property owners asking for the widening of Franklin Street is insufficient, that the Manager is instructed to proceed with the paving work as originally ordered by this Board.

The question of borrowing money to carry on the curb and gutter construction was brought up for consideration and upon the motion of Alderman G.M. Braune, seconded by Alderman C.T. Durham, the following resolution was adopted, all the Aldermen present voting in the affirmative therefor - to wit: Aldermen G.M. Braune, C.T. Durham, M.E. Hogan, C.L.Wills and B.S.Williams; said resolution being as follows:

BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL;

Section 1. That in order to anticipate the receipt of the proceeds from the sale of \$8,000.00 of curb and gutter bonds of the Town of Chapel Hill, authorized by the Board of Aldermen on the 22nd day of December, 1924, said ordinance having duly taken effect upon its passage, and for the purpose of carrying on and completing the work for which the bonds are to be issued, it si necessary to borrow the sum of \$4,000.00 in anticipation of the said sale.

Section 2. Tht a temporary loan of \$4,000.00 shall be made bearing interest at not more than six percent per annum and maturing not later than June 1, 1925; sad loan shall be evidenced by a note and the Mayor and Town Business Manager are hereby delegated to fix the face amount of said note and the rate of interest they are to bear and to fix the date of maturity, all within the limitations herein set forth, and with the power to dispose of said note to the best

Section 3. That the said note shall be signed by the Mayor and countersigned by the Clerk under the corporate seal of the Town, no couponds shall be attached thereto to ewidence the
