Upon motion of Alderman Hogan, seconded by Alderman Thompson, the above schedule was adopted. All members of the Board of Alderman present voting in the affirmative therefor.

The Manager stated that the Graham Truck bought in 1924 was giving considerable trouble, and advised that a new truck be purchased.

The Mayor appointed Mr. Burch and Mr. Hogan, together with the City Manager, as a Committee to go into the matter of purchasing a new truck, and report back at the next meeting of the Board.

The Manager stated that the Improvement Fund was overdrawn due to the purchase of fire hose and changing the wheels and tires on the fire truck, and other miscellaneous purchases of equipment.

Upon motion of Alderman Hogan, seconded by Alderman Braune, the following ordinance authorizing \$2,000 Equipment Bonds was introduced, all members of the Board of Aldermen voting in the affirmative therefor, said ordinance being as follows:

### EQUIPMENT BONDS

# BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL:

- Section 1. That the Town of Chapel Hill do issue its bonds pursuant to the Municipal Finance Act to an amount not exceeding \$2,000 for the purpose of purchasing equipment.
- Section 2. That a tax sufficient to pay the principal and interest of said bonds shall be annually levied and collected.
- Section 3. That a statement of the debt of the Town has been filed with the Clerk and is open to public inspection.

Section 4. That this ordinance shall take effect thirty days after its first publication unless in the meantime a petition for its submission to the voters is filed under said Act, and that in such event it shall take effect when approved by the voters of the Town at an election as provided for in said act.

The foregoing ordinance was passed on the 24th day of June, 1929, and was first published on the 28th day of JUNE, 1929.

Any action or proceeding questioning the validity of said ordinance must be commenced within thirty days after its first publication.

Upon motion of Alderman Hogan, seconded by Alderman Burch, the Manager was instructed to have the auditor prepare statement giving the status of the Improvement Fund.

Alderman Braune stated that Mr. Waldrop, State Highway Engineer, would be glad to come over and talk to the Board of Alderman in regard to surface treatment for the streets of Chapel Hill.

Upon motion of Alderman Burch, seconded by Alderman Hogan, the Manager was authorized to invite Mr. Waldrop to come to Chapel Hill and talk to the Board of Aldermen, in regard to surface treatment. A call meeting of the Board of Aldermen to be held at such time as Mr. Waldrop could come over.

Upon motion, the meeting of the Board of Aldermen adjourned at 9:15.
