There was a called meeting of the Board of Aldermen, Town of Chapel Hill, held at Eight O'clock P. M., August 9, 1930, in the Office of the Bank of Chapel Hill, Mayor Council presiding, with Aldermen Hogan, Burch, Braune and Eubanks present. Town Attorney, Sawyer, was also present.

Upon motion of Alderman Braune, seconded by Alderman Hogan, the following Ordinance was introduced, - all the aldermen present voting in the affirmative therefor:-

AN ORDINANCE

AUTHORIZING \$35,000 SEWER BONDS.

BE IT ORDAINED BY THE BOARD OF ALDERMEN, TOWN OF CHAPEL HILL, NORTH CAROLINA,-


- Section 1, That the Town of Chapel Hill do issue its Bonds pursuant to the Municipal Finance Act, to an amount not exceeding Thirty-Five Thousand Dollars, (\$35,000.00) for the purpose of remodeling, enlarging, and improving the present Municipal Sewage Treatment Works;
- Section 2, That the City Manager shall prepare necessary statement to have the State Sinking Fund Commission approve the financing of the improvement;
- Section 3, That the University of North Carolina agrees to pay Fifty Per Cent of the improvement;
- Section 4, That a tax sufficient to pay the principal and interest on the said bonds shall be annually levied and collected;
- Section 5, That a Statement of the Debt of the Town has been filed with the Clerk and is open to public inspection;
- Section 6, That this Ordinance shall take effect upon its final passage, and shall not be submitted to the voters;
- Section 7, That the City Manager is instructed, after the necessary arrangements have been made, to secure bids for the project.

There being no further business, the meeting of the Board of Aldermen adjourned.

There was a called meeting of the Board of Aldermen, Town of Chapel Hill, held at 10:000 clock A.M. September 8th, 1930, in the Bank of Chapel Hill, Mayor Council presiding, and Aldermen Hogan, Bubanks and Burch present. Alderman Thompson accepted notice of the meeting.

There was a called meeting of the Bornd of Aldermen at the Town Hall at 2:00 O'clock P. M. on September 8th, 1930, Mayor ouncil presiding, with the following Aldermen present: Mayors Eubanks, Braune, Burch, Hogan and Thompson.

The Manager stated this was the hour appointed for the opening of the bids for the Street Improvement. Bids were received from Mrssrs. R. G. Lassiter & Company, and from Mrs. Homewood and Cobb, Inc.

The bids were compared, and the bid of Messrs Homewood and Cobb were announced as the lowest bidder. Upon motion of Alderman Hogan, seconded by Alderman Burch, it was moved that the contract be awarded to Messrs. Homewood and Cobb, Ind., all the Alderman present, voted in the affirmative therefor.

Mr. H. G. Baity, Sanitary Engineer, had been requested to submit to the Board a proposition in regard to designing a sewage treatment plant for the Town and the University. Mr. C. T. Woollen, Busness Mgr. of the University, stated that the University would like to have Mr. Baity design the plant. Mr. Baity stated he was much interested in the plant, and being an alumnus of the University, and a resident of the Town, and as a member of the University faculty, he expected to use this plant as his demonstration plant work.

Mr. Baity stated that the usual fees for such work amounted to from nine to ten percent of the total, but that he would do the engineering complete for 6%, that is, definitely designing and supervision.

Upon motion of Alderman Hogan, seconded by Alderman Burch, it was moved that Mr. H. G. Baity be appointed as engineer for the construction of the Sewage Plant. All the Alderman present voted in the affirmative therefor.

Mr. Baity stated that he would begin at once on the preparation of the plans and specifications.

There being no further business, themmeeting of the Board of Aldermen adjourned.
