The regular monthly meeting of the Board of Aldermen was held at the Town Hall at 8:00 P. M., Mayor Council presiding, and the following Aldermen present, - Messrs. Hogan, Burch, Eubanks and Trimble. Attorney Sawyer and Auditor Rogerson were also present.

The minutes of the meeting of May 27th and June 1st were read and approved.

Attorney Sawyer stated that the Clerk of Court should give \$1,000.00

bond.

The matter of refund for taxes for money derived from the Veterans' Compensation invested in real estate, which was demanded by Mr. Paul Roberson, was left to a committee composed of the Town Attorney, the Town Manager and Mr. Hogan.

Mayor Council appointed Alderman Eubanks and Alderman Trimble a committee to study the license and privilege tax now charged, and to revise and make recommendations at the next meeting of the Board of Alderman.

Mayor Council appointed Mr. Hogan and the Town Manager to go into the matter of tax refund for Mr. W. A. Lloyd, and to make a report in regard to this matter.

Since a part of the Aldermen had heard the report of the departments read at the Rotary Club, it was moved by Alderman Trimble, seconded by Alderman Eubanks, that the reports be accepted, but not read. All the aldermen present voting in the affirmative therefor.

Upon motion of Alderman Burch, seconded by Alderman Eubanks, the following Budget Transfers were authorized, - all the Alderman present, voting in the affirmative therefor. (See same attached or copied on Page 106 of this Minute Book)

Mayor Council read a letter of resignation from Dr. R. D. W. Connor, a member of the Board of Aldermen.
