Mr. Zeb P. Council, former Mayor, appeared before the Board and swore in the new Mayor, J. M. Foushee.

The following subjects were brought up and handled as indicated below.

Subject: Mayor Pro-tem.

On motion of Mr. Hogan seconded by Mr. Dobbins, the Board appointed Mr. Eubanks as Mayor Pro-tem.

Minutes of the Meeting of the Board of Aldermen held in April were read and approved by the Board.

Subject: Applications for Clerk of Recorder's Court.

On motion of Mr. Burch seconded by Mr. Hogan the Board was in order to appoint a Clerk. The Town Manager read the applications from Mr. R. C. Andrews and Mr. M. W. Durham. On motion of Mr. Burch seconded by Mr. Dobbins and passed by the Board Mr. R. C. Andrews was appointed Clerk of Recorder's Court.

Subject: Application for Town Attorney.

The Town Manager read the letter from the incumbent Attorney Sawyer. On motion of Mr. Eubanks seconded by Mr. Dobbins and passed by the Board Mr. B. D. Sawyer was appointed to succeed himself.

Subject: Application for Prosecuting Attorney.

On motion of Mr. Hogan seconded by Mr. Dobbins the Board was in order to appoint a prosecuting attorney for Recorder's Court. On motion of Mr. Hogan seconded by Mr. Eubanks and passed by the Board Mr. B. D. Sawyer was appointed prosecuting attorney for Recorder's Court.

Subject: Recorder's Court Hours.

Mr. L. J. Phipps appeared before the Board asking that the Board change the hours of Recorder's Court from Saturday afternoon to Tuesday morning at ten o'clock. On motion of Mr. Eubanks seconded by Mr. Hogan and passed by the Board the hours of Recorder's Court were changed from Saturday afternoon to Tuesday morning of each week at ten o'clock.

Mr. Phipps also asked that the Board have the telephone back of the court room moved. The Board decided to authorize the Town Manager to take care of the telephone.

Subject: Vice Recorder.

Motion was in order for a Vice Recorder. On motion of Mr. Hogan seconded by Mr. Thompson and passed by the Board Mr. C. P. Hinshaw was appointed Vice Recorder.

Subject: Beer License in Chapel Hill.

The Town Manager stated that eight beer licenses had been sold. He stated to the Board that there were two houses; namely, Sutton's Drug Store and Carolina Smoke Shop that had been selling beer without a Privilege. On motion of Mr. Hogan seconded by Mr. Thompson and passed by the Board the above two firms were granted Privilege Licenses. On motion of Mr. Burch seconded by Mr. Dobbins and passed by the Board the eight licenses above issued by the Town Manager be approved by the Board.

Subject: Firemen's Barbecue.

On motion of Mr. Hogan seconded by Mr. Eubanks and passed by the Board Mr. Burch was appointed to see the firemen and talk with them and let them know that the town does not have enough money for them to have the Barbecue and go to the Firemen's Convention also. If he could so arrange with them to have the Firemen's Barbecue and to let them have it and the expense be paid out of the Convention fund, provided there are enough funds available.

Subject: Light on Cotton Street.

The Manager stated that the nurse of the Health Department had given him a petition of the people on Cotton Street asking that they be given lights on these streets. On motion of Mr. Eubanks seconded by Mr. Hogan and passed by the Board it was moved that the Light Committee and Town Manager look into the matter and give them the power to act, provided they have sufficient funds.

Subject: Case of Jim Wills.

Attorney Sawyer stated to the Board that Attorney Young & Long had written to him stating they would be willing to settle the case of Jim Wills for \$250.00

Subject: Building Inspector.

Subject: Brick Building of Mr. Brockwell's.

The Board decided that the inspectors pass on the inspection of that building with the State Officials.

Subject: Sewer Construction on Ransom Street.

The Town Manager reported to the Board that the construction on Ransom Street of approximately 640 feet had been completed, the cost being \$417.00 thus far.

Subject: Mower Attachment for Tractor.

The Board decided that the Town Manager see Mr. Brodie Lloyd and see if he would not let the Town use the mower for a day or two and give them a chance to see it in operation before purchasing it.

Reports from the various departments were read and approved by the Board.

Subject: Dairies with Bacterial Count over 25,000.

On motion of Mr. Dobbins seconded by Mr. Burch and passed by the Board the Town Manager was instructed to write each dairy that showed a bacterial count of 25,000 or over a letter calling their attention to the high bacterial count.

There being no further business, the Meeting of the Board of Aldermen adjourned.
