

Minutes of the Meeting of the Board of Aldermen, Town of Chapel

The regular Meeting of the Board of Aldermen was held in the Town Office at 8 o'clock P. M., November 8, 1933. Present were Mayor J. M. Foushee and Aldermen Dobbins, Thompson, Burch, Eubanks, Hogan and Connor; also present were Town Accountant Rogerson and Town Attorney Sawyer.

The following subjects were brought up and handled as indicated.

Minutes of the meeting of the Board held in Oct. were read and approved by the board.

Subject: Play Ground for the School.

Mrs. Logan, Mrs. Breckenridge and Mrs. Hudson appeared before the board in behalf of the School asking that the town help them raise the money, approximately \$300.00 to fix the play ground for the school children. After a thorough discussion, the board asked that Mrs. Logan ask Mr. Roberson or Mr. Munch to call a meeting of the School Board and take this matter up with the School Board.

The reports from the Health and Police Department were read and approved by the Board.

Subject: Light on Hooper Lane.

The City Manager stated that Mrs. Rees had asked that the town install a light down on her street. On motion of Alderman Dobbins, seconded by Alderman Hogan and passed by the Board that the light be referred to the Committee on Public Utility for him to investigate and install where most needed, provided the town does not have to pay any of the cost.

ments as outlined by Mr. L. B. Rogerson be made out each month for the benefit of the board.

1. Forecast of cash position by funds for current month and for next month.

2. Appropriation balance by funds and by departments, showing per cent of appropriation used this year to date and compared with same period previous year.

3. Unrealized income by fund and by sources, showing per cent of estimate realized this year to date and compared with same period previous year.

4. Unpaid taxes by funds and by years, showing per cent of levy unpaid to date, and per cent of tax unpaid to this same date in each of three previous years.

5. Unpaid special assessments by years, showing per cent of unpaid to total assessed.

6. Unpaid general accounts Receivable, showing amount outstanding at beginning of year, additions thereto during the year to date, collections during the year to date, outstanding at date, and also per cent of current collections to current charges.

7. Condensed balance sheet by funds.

There being no further business, the Meeting of the Board of Aldermen adjourned.
