

Minutes of Meeting held July 11, 1934.

The regular Meeting of the Board of Aldermen was held in the Town Hall at 8:00 o'clock P. M., July 11, 1934, with Mayor J. M. Foushee presiding and the following Aldermen present: Messrs. C. L. Eubanks, J. T. Dobbins, P. L. Burch and M. E. Hogan.

Due to the fact that there was to be a public meeting in regard to change between Henderson Street to Pine Street, which is known as Resident Zone B to be changed from Resident Zone B to Business Zone # 2, and the office not being sufficient to take care of the crowd, motion was made by Alderman C. L. Eubanks, seconded by Alderman J. T. Dobbins and passed by the Board in the affirmative that the members of the Board go to the Old Pickwick Building for the public meeting.

Mayor J. M. Foushee stated that the purpose of the meeting was to have a public hearing of the people in regard to change in zoning ordinance on Franklin Street that portion of Franklin Street on the North side between the Presbyterian Church and Pickard Street.

Subject: Change in Zoning District.

The following people came before the board and expressed objections to any change being made in the zoning ordinance: Dr. J.<sup>m</sup>. Booker, who was the first one to speak read a letter he had received from Dr. Coker, Chairman of the grounds committee, stating that he was against any change in the zoning district. Dr. Booker in conclusion stated that the letter he had just read expressed his ideas in regard to the change. The following other people also expressed objections to any change being made; Mrs. Koch, Mrs. Booker, Mrs. Mebane, Mrs. Crockford, Mrs. A. A. Kluttz, Mrs. Branson, Dr. Bullitt, Mr. & Mrs. McClamroch, Rev. A. S. Lawrence, Mr. VanHecke, G. A. Harrer, Dr. Edminister, Mr. H. D. Carter, Dr. H. D. Myer, and Mrs. George Howard. In conclusion Mr. R. B. House stated that he had talked with president Graham in regard to the change and he had been authorized to say that the University was opposed to any change being made.

After every person present had been given the privilege to express his ideas in regard to the change, motion was made by Alderman Burch, seconded by Alderman Dobbins all Aldermen present voting in the affirmative therefor, the meeting of the Board of Aldermen adjourned into executive session.

Subject: Action on Zoning Ordinance

Motion was made by Alderman Hogan, seconded by Alderman Burch and passed by the Board in the affirmative that the action on the Zoning Ordinance be postponed until there is a full meeting of the Board.

Motion was made by Alderman Hogan, seconded by Alderman Dobbins, all Aldermen present voting in the affirmative therefor that the Town Manager, Alderman Eubanks, and Alderman Burch work out the license schedule for 1934-35.

Motion was made by Alderman Hogan seconded by Alderman Dobbins and passed by the the board in the affirmative that the Board adjourn until such time as the Mayor will call a special meeting, at which time the Board will take up the budget and schedule for privilege license tax for 1934-35.
