

Minutes of Meeting held Sept. 20, 1934.

Book 6, Page 347.

There was a called Meeting of the Board of Aldermen at the Town Hall at 7:15 o'clock P. M., September 20, 1934, Mayor J. M. Foushee presiding and the following Aldermen present: M. E. Hogan, C. L. Eubanks, R. D. W. Connor, P. L. Burch and J. T. Dobbins.

The purpose of this meeting was to take further action in the case of the Clerk of Recorder's Court.

At the regular meeting of the Board of Aldermen on September 12, 1934, the office of the Clerk of Recorder's Court was declared vacant due to action of the incumbent, Mr. Paul Robertson an accepting work at Durham and intrusting his records to someone else without notification or authority of the Board of Aldermen. At that meeting the City Manager recommended Miss Lillian Lloyd for the position of Clerk of Recorder's Court, and upon motion of Alderman R. D. W. Connor, seconded by Alderman J. T. Dobbins she was unanimously confirmed for the place.

The following morning after the regular meeting, the resignation of Mr. Paul Robertson was handed to the City Manager by Mr. C. P. Hinshaw, and subsequently he wrote the Board on September 19, asking that his resignation be rescinded for the reason explained in his letter herewtih as a part of these minutes.

After full discussion of the Board, the City Manager recommended that Miss Lillian Lloyd be relieved from duties as Clerk of Court, since she had not yet qualified and it was decided that duties of her work at the Town Hall were too numerous for carrying on work as Clerk of Recorder's Court in addition to her regular routine. The City Manager recommended Mr. M. W. Durham to perform the duties of Clerk of Clerk of Recorder's Court and upon motion of Alderman C. L. Eubanks, seconded by Alderman R. D. W. Connor Mr. Durham was unanimously appointed Clerk of Recorder's Court to take effect at once.

There being no further business, the Meeting of the Board of Aldermen adjourned.
