

Minutes of the Meeting held December 12, 1934.

The Regular Meeting of the Board of Aldermen was held in the Town Hall at 8 o'clock P. M., December 12, 1934, with Mayor J. M. Foushee presiding and the following Aldermen present: Messrs. J. T. Dobbins, C. L. Eubanks, and R. J. M. Hobbs. Present also was Town Accountant M. L. Thompson and Town Attorney B. D. Sawyer.

Minutes of the meeting of the Board held November 14, were read and approved by the Board.

Reports from the various departments were read and approved by the Board.

The following subjects were brought up and handled as indicated.

Subject: Street Lights.

After a discussion of the board, motion was made by Alderman Dobbins, seconded by Alderman Eubanks all Aldermen present voting in the affirmative therefor that the City Manager be authorized to have Street lights installed at the following places, provided the cost of installing these lights does not exceed \$20.00: One on West Franklin St., at the rear of the Lloyd building, one on Glandon Drive near W. C. Georges and two in Pottersfield where most needed.

The Mayor appointed Dr. R. J. M. Hobbs, Chairman of the Public Utility Committee to succeed Dr. R. D. W. Connor, resigned.

Subject: F. H. Sparrow's Sewer Rent.

The City Manager reported to the board that he had talked with Mr. Sparrow, as per instructions of the board, and Mr. Sparrow had declined to make any compromise in any way, or pay the sewer rent.

Subject: Old Dalton Adding Machine.

The City Manager stated that he could sell an old Dalton Adding Machine, which belonged to the town to be used as repair parts for \$20.00. After a full discussion of the Board, motion was made by Alderman Eubanks, seconded by Alderman Dobbins all Aldermen present voting in the affirmative therefor that the City Manager be instructed to sell the adding machine.

Subject: Bond for Tax Collector.

The City Manager read certain resolutions from the National Surety Corporation which the Board would have to pass before it would be possible for them to write a bond for the Tax Collector. After it was discussed by the board, the Mayor referred this matter to Mr. Hogan, Chairman of the Finance Committee and Mr. R. J. M. Hobbs, for their consideration and report at the next meeting.

Subject: Street Decoration.

Alderman Eubanks stated that the merchants of the town felt that the town should be willing to contribute as much as \$50.00 to the decoration of the streets. After a full discussion of the board, motion was made by Alderman Eubanks, seconded by Alderman Dobbins all Aldermen present voting in the affirmative therefor that the town appropriate \$50.00 to the decoration fund for 1934.

Subject: Milk Ordinance submitted to the town to be passed by the Board.

After the Milk Ordinance had been discussed by the board, the Mayor appointed Alderman Eubanks and Alderman Dobbins as committees to meet with the State men in regard to this new ordinance and try to work out some plan that would be satisfactory to the State Department and the town.

The Mayor asked Mr. Sawyer to meet with the Judge of Recorder's Court and Prosecuting Attorney in regard to the fines specified on the ordinances now. After he has met with them make his report back to the board as to what he thinks should be done in regard to the old ordinances.

There being no further business, the meeting of the Board of Aldermen adjourned.
