

Minutes of Meeting of Board of Aldermen,
held August 26, 1935.

Book 6. Page 473.

There was a called meeting of the Board of Aldermen held in the Town Hall at 4:00 o'clock P. M., August 26, 1935. In the absence of the Mayor, Mr. C. L. Eubanks, Mayor Pro-tem presided and the following Aldermen were present: Messrs. R. H. Wettach, M. E. Hogan, R. J. M. Hobbs, and P. L. Burch. Mr. M. L. Thompson, Town Auditor was also present.

The purpose of this meeting was to officially confirm the tentative budget for the year 1935-36, after the same had been on display at the Town Hall twenty days as required by law; also to establish the tax rate for the above year, including that for the Chapel Hill Graded School, as per request from the Board of Trustees of the Chapel Hill Graded School in a letter dated August 26, 1935, a copy of which is attached herewith as part of these minutes.

Motion was made by Alderman Hogan seconded by Alderman Burch and passed by the board that the budget as read by Mr. M. L. Thompson, Auditor be adopted for the year 1935-36, a copy of which is herewith attached as part of these minutes. At this time Mayor Pro-tem read the request from the school board asking the town to levy a tax rate of 35¢ for the school.

Motion was made by Alderman Hobbs, seconded by Alderman Wettach and passed by the board that the tax rate for the town be set as follows:

Motion was made by Alderman Hobbs, seconded by Alderman Wettach and passed by the board that the tax rate for the Chapel Hill Graded School be established as follows:

Supplementary Fund	.18 $\frac{1}{2}$
Special Fund (Tax Collecting and Auditing)	.02
Debt Service Fund	<u>.14$\frac{1}{2}$</u>
	.35

Motion was made by Alderman Hobbs seconded by Alderman Wettach and passed by the Board that the tax rate of \$1.60 per \$100.00 real and personal property be established for the Town of Chapel Hill and Chapel Hill Graded School (known as Chapel Hill City Administrative School Unit) for the year 1935-36.


