## Minutes of Meeting of Board of Aldermen held September 11, 1935

The Regular Meeting of the Board of Aldermen was held in the Town Hall at 8 o'clock P. M., September 11, 1935. In the absence of the Mayor, Alderman C. L. Eubanks, Mayor Pro-tem presided and the following Aldermen were present: M. E. Hogan, P. L. Burch, J. T. Dobbins and R. J. M. Hobbs.

The following subjects were brought up and handled as indicated:

Minutes of the regular meeting held August 14, and the called meeting held August 26, were read and approved.

Reports from the various departments were read and approved.

Mr. E. P. Carruthers, Sanitary Inspector, came before the Board of Aldermen in regard to the dairy situations in and around Chapel Hill. He stated that he had visited all the dairies with the view of getting them to improve their conditions and bring them up the State Board of Health Requirements.

Subject: Mr. W. T. Sloan and duties of Chief as required by the Board of Aldermen.

Mr. Sloan, the newly appointed Chief of Police, came before the Board in an effort to learn the duties of the Chief under the new police set up. Mr. P. L. Burch, Chairman of the Public Safety Committee, explained in detail the functions of the Police Department under the new Chief as follows:

- 1. Police Department to be set up as a separate department under the direct control of the Chief of Police, who has entire jurisdiction over the Police Department, and who is responsible to the Board of Aldermen through the City Manager.
- 2. The Chief of Police responsible to the Board of Aldermen through the City Manager. The City Manager to act as a door-way for the Police Department to the Board of Aldermen. He is to submit reports from the Chief to the Board and visa versa.
- 3. Function of the Police Commissioner and Gity Manager. The Police Commissioner and the City Manager are to act only in an advisory way to the Chief. If at any time the Chief, Police

Commissioner and the City Manager do not agree upon a matter, it is then to be submitted to the Board of Aldermen for their decision. The Chief of Police to act on his judgment at all times.

4. The Chief of Police shall have the authority to select the Patrolmen who are to work under him, subject to the approval of the Board of Aldermen.
