The regular meeting of the Board of Aldermen was held in the Town Hall at 8 o'clock P. M., October 9, 1935. Mayor J. M. Foushee presided and the following Aldermen were present: C. L. Eubanks, M. The following subjects were handled as indicated:

Subject: Mr. Humphreys from Carolina Coach Company came before the board in regard to Traffic Situation on Main Street.

Mr. Humphreys from the Carolina Coach Company came before the Board in regard to the congested traffic situation on Main Street. He stated that the Carolina Coach Company was willing to co-operate with the town to every extent possible. He further stated that he had made four trips over here in an effort to find a location that he had made four trips over here in an effort to find a location for the bus station, which seemed almost an impossible task, since all the buildings available for rent were occupied at this time. Motion was made by Alderman Hogan, seconded by Alderman Dobbins and passed that the committee composed of Alderman Eubanks, Burch and the City Manager be continued and to work with the Carolina Coach Company with the view of trying to reach some solution that would relieve the traffic situation on Main Street.

Subject: Letter from Merchant's Association in regard to boys selling sandwiches.

Alderman Eubanks read a letter that had been presented to him by the Merchant's Association in regard to boys selling sandwiches in town. Motion was made by Alderman Eubanks, seconded by Alderman Hogan and passed that Mr. E. P. Carruthers, Sanitary Inspector, be instructed to inspect all places where sandwiches are being made and learn the conditions under which the sandwiches are made. Also the City Manager to conditions under which the sandwiches are made. Eigenses from all boys instruct the Chief of Police to collect Privilege Licenses from all boys selling sandwiches.

Subject: Assistant Recorder.

Motion was made by Alderman Burch, seconded by Alderman Eubanks and passed that Mr. C. P. Hinshaw be appointed as Assistant Recorder for Recorder's Court.

Subject: Bill from N. C. Municipal League.

Mayor J. M. Foushee presented a bill from the N. C. Municipal League for 26.99, dues to the League for 1935-36. Motion was made by Alderman Hogan, seconded by Alderman Burch and passed that the bill of 26.99 be paid the N. C. League and the amount charged to the continguent fund.

Subject: Coal for Health Organization.

The City Manager was instructed to take the matter of getting coal for the Health Organization up with Mr. L. B. Rogerson, Comptroller, of the University of N. C., and ascertain if the University would be willing to help the Town furnish coal for the Health Organization.

Subject: Letter from Garden Club.

Mr. John M. Foushee read a letter from the Garden Club in which they were asking the assistance of the town labor to help prepare the old Patterson Lot, now owned by the Bank of Chapel Hill and located at the back of the Post Office, for a flower garden. Motion was made by the back of the Post Office, for a flower garden. Motion was made by Alderman Hogan, seconded by Alderman Burch and passed that Alderman Dobbins and Alderman Eubanks work with the City Manager and see what contributions the town can make toward the planning of the flower garden.

Subject: Government Funds Allotted to Orange County for Schools.

Alderman Hogan stated that the Government had allotted

more money to the county for school buindings than they would use for that purpose and it might be possible that the town could get some of the funds to be used for building a Town Hall. After a discussion the Mayor appointed Alderman Hogan and the City Manager to investigate and ascertain if it would be possible for the town to get some of the funds to be used for building a Town Hall.

Subject: Seal Coating Streets.

Motion was made by Alderman Dobbins, seconded by Alderman Eubanks that all streets be seal coated at the best contract price available.

Subject: Engineer for Town.

Mayor J. M. Foushee appointed Alderman Hogan and the City Manager to meet with Mr. A. R. Hollett to determine his salary for engineering work in connection with seal coating streets.

Motion was made by Alderman Eubanks, seconded by Alderman Dobbins and passed that the meeting of the Board of Alderman adjourn.
