The regular meeting of the Board of Aldermen was held in the Town Hall at 8 o'clock P. M., April 8, 1936. Mayor J. M. Foushee presided and the following Aldermen were present: C. L. Eubanks, P. L. Burch, M. E. Hogan and R. H. Wettach. Town Attorney, B. D. Sawyer, and Town Accountant, M. L. Thompson were also present.

The following subjects were brought up and disposed of as indicated:

Minutes of the regular meeting held March 25, were read and approved by the Board.

Subject: Clerk of Recorder's Court requested to give monthly report to Board of Aldermen.

Motion was made by Alderman Hogan, seconded by Alderman Wettach that the Clerk of Recorder's Court be requested to furnish the Board of Alderman with monthly report showing the number of cases brought into the court, the disposition made including the fines if fined, or imposed, if taken an appeal, or any other sentence that might be given. The City Manager was instructed to send the Clerk of Recorder's Court a copy of this resolution.

Subject: Property owners on Franklin Street requested to connect up to storm sewer.

Motion was made by Alderman Eubanks, seconded by Alderman Burch that property owners on the North side of East Franklin Street be requested to connect up to the storm sewer in rear of their property.


Subject: Garbage Situation on Patterson Place & McCauley St.

Alderman Burch stated that he had received several complaints in regard to people living on Patterson Place and McCauley Street disposing of their garbage in the cut on the railroad. The City Manager was instructed to have the police notify the people living on Patterson Place and McCauley Street that they could not dispose of their garbage in such a manner as above stated.

Subject: Restricted area for cows in Chapel Hill.

Motion was made by Alderman Eubanks seconded by Alderman Burch that the restricted area for cows in Chapel Hill be extended from the town's eastern limit in line with North Street; North Street to Columbia; Columbia to Carr; Carr to Church; Church to Rosemary; Rosemary to Graham; Graham to Cameron Avenue to Ransom; Ransom to the town's southern limit.

Subject: Lot immediately East of the Presbyterian Church deemed a corner lot.

Motion was made by Alderman Hogan, seconded by Alderman Wettach that the vacant lot immediately East of the Presbyterian Church on East Franklin Street and owned by Mr. R. P. McClamroch be deemed a corner lot by the Board of Alderman.

Subject: Parking limit in Chapel Hill.

The City Manager was instructed to request the police to check on the parking limit in the business district on Franklin Street, also to check on the students bumming rides, particularly in front of postoffice.

Subject: Collection of delinquent taxes.

Motion was made by Alderman Hogan, seconded by Alderman Eubanks that the City Manager be instructed to make a special effort to collect all taxes due the town.

There being no further business, the meeting of the board adjourned.
