A called meeting of the board of Aldermen of the Town of Chapel Hill was held in the 'own Office, "ednesday, Sept. 22, 1937, at 8:00 P. M. Mayor J. M. Foushee presided and the following "Idermen were present: Messrs. ". B. "ellen, P. L. Burch, F. O. Dowman, R. J. M. Hobbs, Paul Robertson, and R. H. Wettach. Also present were Messrs. C. P. Hinshaw and E. Peacock.

SUBJECT: Appointment of Town Accountant and Clerk.

On motion by G. B. Hellen and seconded by F. O. Bowman, the board confirmed the appointment of W. S. Swaim as Town Accountant and Clerk, the appointment being made in August by Mr. J. L. Caldwell, City Manager and Mr. E. E. Peacock, City Auditor.

SUBJECT: Public Improvement Bond Issue.

Discussion concerning the new bond issue was deferred until the next regular meeting.

SUBJECT: Audit Report by E. E. Peacock.

Mr. Peacock presented a list of delinquent tax payers which he suggested be placed in a suspense ledger for two or three years before writing them off. After reading this list, which is attached to the minutes, the board recommended that a number of names be taken out of the suspense ledger and placed on the list to be given to the police and attorney for collection. The last named lists are also attached to these minutes.

A second list comprising taxpayers who have balances long over-due and who have moved away was read. Mr. Peacock and Mr. Caldwell recommended that all be released as it would be useless and costly to try collecting them. Alderman Hellen motioned that they be released on Mr. Peacock and Mr. Caldwell's recommendations. Alderman Burch seconded the motion. The list follows these minutes.

Auditor Peacock reported that forty-two taxpayers had contested charges against them. In regard to thirty-six of these taxpayers, Mr. Caldwell agrees that the charges were made erroneously. As for the other six, Mr. Caldwell doesn't know. On motion by Alderman Burch, seconded by Alderman Bowman, the board recommended that all forty-two names be released.

A certain number of delinquent taxpayers are still in town and have property which can be foreclosed. Mr. Peacock suggested that this list, which is attached, be turned over to the police for collection. On motion by Alderman Robertson, seconded by Alderman Wettach, the Board accepted the list as made by Mr. Peacock and agreed that it be turned over to Chief Sloan for collection.

APPOINTMENT OF ASSISTANT TAX COLLECTOR -- On motion by Alderman Robertson, seconded by Alderman Hobbs, the board appointed Chief Sloan as Assistant Tax Collector for the Town of Chapel Hill.

Alderman Hobbs motioned that a temporary receipt book be made and be used by the Police in collecting the delinquent taxes. The receipt will be given to the taxpayer who in turn will exchange it for an official receipt at the town office. Alderman Hellen seconded the motion.

In order to comply with the garnishee law, the board appointed Mr. Caldwell to notify Mr. Graves that he is to notarize a list of names whose wages will be garnisheed for taxes.

Mr. Peacock stated that he had compiled a list of names who had paid taxes for which there had been no charge made. Mr. Caldwell stated that the charges should have been made but were overlooked. Alderman Bowman motioned that the charges be made and Alderman Robertson seconded the motion.

Another list which comprises taxpayers, who have moved away and do not deny the charges, will be turned over to the attorney for collection. This list is also attached to the minutes. On motion by Alderman Wettach and seconded by Alderman Hellen, the board moved that the list be accepted as compiled by Auditor Peacock.

Fifty-seven accounts were found to have charges which should have been made to other accounts. On motion by Alderman Habbs, seconded by Alderman Bowman, the Board agreed to accept the auditor's recommendation that the chargea be transferred to the correct account.

Three taxpayers claimed that they paid Mr. McCauley and produced receipts in evidence. On motion by Alderman Wettach, seconded by Alderman Hellen, the board moved to credit the taxpayers' account and to charge Mr. McCauley with the total.of the same.

On motion by Alderman "ellen, seconded by Alderman Wettach, the board agreed to charge off taxes erroneously listed by Mr. Edwin Lanier, and agreed that he should pay the same amount of taxes for 1935 as he paid the following year.


