The Board of Aldermen of the Town of Chapel Hill held the regular monthly meeting on August 10, 1938, in the Town Office at 8 o'clock P.M. Alderman Hobbs presided in the absence of Mayor Foushee and the following aldermen were present: Messrs. P. L. Burch, G. B. Hellen, P. H. Robertson, F. O. Bowman and R. J. M. Hobbs.

After the Mayor Pro-Tem called the meeting to order, the Clerk read the minutes of the last regular meeting and the two called meetings after which the Board approved.

Subject: Westwood Boundary Survey.

Mr. Caldwell reported that the survey had not been completed, and also that an aerial survey would be made.

Subject: Changing of Zone in Pritchard Field.

The Board of Aldermen asked the City Attorney to draw up a new Zoning Ordinance which would effect a change from Residence Zone B to Residence Zone A in the area surrounding Pritchard Avenue as requested by the signers of a petition, and present it to the Board at the next meeting.

Subject: Taxi Zone.

Alderman Burch reported that the Public Safety Committee had not made an investigation, but would at the next meeting.

Subject: Donation to Institute of Government.

Mr. Hinshaw reported that all taxes had been paid on the property which the Institute of Government had bought. He also stated that the Institute would appreciate a donation for services from the Town.

Upon motion by Alderman Burch and seconded by Alderman Robertson, the Board of Alderman of the Town of Chapel Hill in the form of a resolution endorsed the Institute of Government's project and progress and expressed its desire to make a contribution to the Institute for services rendered at any future date - whenever the Town felt that it would be financially able to do so.

Subject: Sewage Treatment Plant Extension.

The City Manager reported that the PWA application for the Sewage Treatment Plant Extension had been filed, and that the additional features of the Treatment Plant Extension would provide for a normal growth of the Town for 10 years.

Subject: \$24,000 Bond Anticipation Note.
The City Manager reported that no notes were sold upon advice from Mr. Morehead, bond attorney for the town. 780

Subject: Wage Scale for Municipal Building.

Mr. Caldwell and Mr. Burch stated that they had been informed that a lower wage schedule had been approved for Durham than Chapel Hill.

Upon motion by Alderman Bowman, and seconded by Alderman Hellen, the Board instructed the City Manager to enter a written protest with the PWA authorities protesting against a higher wage scale for PWA work in Chapel Hill than in Durham, and to follow up with correspondence.

Subject: The Police Report was read by the Clerk and approved by

Alderman Burch reported that the Police Department had not been taking any action upon the second offense. A new ordinance fixing a fine for parking over lines and violating traffic ordinances needs to be passed. Mr. Hinshaw stated that court costs for traffic violations were the Board. too high and that a new ordinance was needed.

Upon motion by Alderman Bowman, and seconded by Alderman Robertson, the Board instructed the Town Attorney to ammend the ordinance fixing court costs and draw up an ordinance fixing a fine on traffic violations.

Subject: Taxes on Mrs. R. D. Cheek Property.

Mr. Caldwell reported tht Mrs. Cheek stated that she had never received mr. Subject: Fire Equipment for Out of Town Residents.

Subject: Sale of Old Town Hall.

Mr. Caldwell reported that the old Town Hall was sold for \$32.50.

Subject: WPA Project.

Upon motion by Alderman Burch and seconded by Alderman Dowman, the Board authorized the City Manager to start work and bring labor from Efland as soon as official notice is received that the project was approved.

Subject: The Board of Aldermen resolved that the police department should be cautioned to prohibit the riding of bycycles on sidewalks.

Subject: Appointment of Mr. R. W. Madry to Board.

Two candidates to fill the vacancy created by the resignation of R. H. Wettach was presented to the Board as follows: Mr. J. T. Dobbins a d Mr. R. W. Madry. In a vote by show of hands Mr. T. W. Madry was appointed by a vote of three to two to succeed Mr. R. H. Wettach as member on the Board.

Subject: 1938-39 Tax Rate.

Mr. Peacock read a letter from the School Board asking the Town to levy a rate of 33.5¢ per \$100 valuation for the schools for the year 1958-39.

Upon motion by Alderman Robertson and seconded by Alderman Hellen, the Board of Alderman accepted the 3310 vote for the schools.

The Finance Committee recommended the addition of \$600 to the Budget for an Engineer's Salary.

Upon motion by Alderman Burch and seconded by Alderman Hellen, the Board of Alderman set the tax rate for the fiscal year 1938-39 as \$1.55 per \$100 valuation to be divided as follows: General Fund 72%, Debt service 53%, and schools 33%.

Subject: Gasoline Consumption by Town Equipment.

Auditor Peacock gave a report of the gasolin used by Town Equipment since May when the present check up system was installed. A discussion followed concerning whether the Town Manager should buy gasoline from the Town or not.

Upon motion by Alderman Burch and seconded by Alderman Hobbs, the Board of Alderman resolved that the Town Manager could buy his gas from the town at wholesale price if he so desires.

Subject: Compensation to Aldermen and Attendence Requirement.
