

MINUTES OF THE CALLED MEETING OF THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL
HELD IN THE TOWN HALL THURSDAY, MAY 8, 1941

The Board of Aldermen of the Town of Chapel Hill met in special session in the Town Hall on Thursday afternoon, May 8, 1941, to canvas the election returns of the general municipal election held May 6, 1941. Mayor Foushee presided and the following aldermen were present: Messrs. G. B. Hellen, R. W. Madry, F. O. Bowman, P. H. Robertson and R. J. M. Hobbs. Also present were J. L. Caldwell and C. P. Hinshaw.

Subject: Canvassing of Election Returns.

The Clerk read a letter, signed by the registrar and judges, setting forth the names of candidates and the number of votes each received after which the Board adopted the following ordinance upon motion by Alderman Hellen and seconded by Alderman Madry:

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL:

Section 1. WHEREAS, on the 6th. day of May, 1941, a general election was held for the purpose of electing the Mayor, three members to the Board of Aldermen, and a Judge of the Recorder's Court, and whereas, in said election John M. Foushee received 558 votes for Mayor and J. T. Dobbins received 357 votes; Andrew C. McIntosh received 464 votes for Judge of the Recorder's Court and L. J. Phipps received 447; F. O. Bowman received 497 votes for Alderman, R. B. Fitch 733 votes, Braxton Creel 358 votes, G. Obie Davis 496 votes, J. T. Harris 68 votes, G. B. Hellen 453 votes.

Section 2. John M. Foushee having received the highest number of votes for Mayor is hereby declared elected Mayor for the Town of Chapel Hill for the period of two years; Andrew C. McIntosh, having received the highest number of votes for Judge of the Chapel Hill Recorder's Court, is declared elected to that office for the next two years; F. O. Bowman, R. B. Fitch, G. Obie Davis, having received the highest number of votes for membership to the Board of Aldermen, the three are declared elected to that office for the period of the next four years.







I, Andrew C. McIntosh, do solemnly and sincerely swear, that I will support the constitution of the United States and that I will be faithful and bear true allegiance to the state of North Carolina, and to the constitutional powers and authorities which are or may be established for the government thereof; and that I will endeavor to support, maintain and defend the constitution of said state not inconsistent with the constitution of the United States, to the best of my knowledge and ability; so help me, God.

I, Andrew C. McIntosh, do further solemnly swear that as Recorder of the Recorder's Court of the Town of Chapel Hill, Orange County, North Carolina, in all articles in the commission to me directed, I will do equal right to the poor and the rich, to the best of my judgment, and according to the laws of the State. I will not privately or openly, by myself or any other person, be of counsel in any quarrel or suit depending before me; the fines and amercements that shall happen to be made, and the forfeitures that shall be incurred, I will cause to be duly entered without concealment. I will not wittingly or willingly take, by myself or any other person for me, any fee, gift, gratuity or reward whatsoever for any matter or thing by me to be done by virtue of my office, except such fees as are or may be directed and limited by statute; but well and truly I will do my office of Recorder. I will not delay any person of common right, by reason of any letter or order from any person in authority to me directed, or for any other cause whatever; and if any letter or order come to me contrary to law I will proceed to enforce the law, such letter or order notwithstanding. I will not direct, or cause to be directed, to the parties any warrant by me made, but will direct all such warrants to the sheriffs or constables of the county, or the other officers and ministers of the state, or other indifferent persons, to do execution thereof; and finally, in all things belonging to my office, during my continuance therein, I will faithfully, truly and justly, and according to the best of my skill and judgment, do equal and impartial justice to the public and to individuals; so help me, God.
