

MINUTES OF THE SPECIAL MEETING OF THE BOARD OF ALDERMEN IN THE TOWN
HALL ON AUGUST 22, 1942

There was a called meeting of the board of aldermen of the Town of Chapel Hill at 8:00 P. M., August 22, 1942 in the Town Hall. Present were Aldermen E. J. M. Hobbs, F. O. Bowman, R. E. Fitch, G. O. Davis and P. L. Burch. In the absence of Mayor Medry, Alderman Hobbs acted in his stead.

The purpose of this meeting was to take final action on the milk and dairy situation the full details of which are shown in the minutes of previous meetings. Mr. Fred Lloyd, Mr. C. I. Suitt, and Mr. J. E. Andr us were at this meeting to represent the milk producers, and Mr. T. R. Harward and Dave Henry were present to represent the retailers. Representing and speaking for the milk producers Mr. H. A. Whitfield, Mr. Tom Henry, and Mr. J. T. Unstead were present. Dr. Richardson was on hand to act for the Board of Health.

About the same discussions and arguments were presented as indicated in previous meetings on the subject. The milk producers requested further extension of time in order to comply with all the regulations and in the meanwhile wanted the right to deliver their milk to the Durham Road Dairy so there will be no interruption in the delivery. Dr. Richardson objected to further extension of time stating that there had been granted a sufficient length of time and they had not corrected the situation. Mr. Burch of the Board gave his views of the matter. He asked the producers if they had made any effort to correct the violations of the milk ordinance and if they were willing in the future to correct all violations so they could be regulated to meet the requirements. The producers were in full agreement to this. Dr. Richardson stated that some improvements had been made and the producers stated that they would comply fully. Mr. Fitch explained at length his ideas on the matter relating his visits to the dairies and expressing himself in favor of giving them a further extension of time. At this point Dr. Richardson stated that if further time were extended he begged to be relieved of all the responsibility as to the milk situation in the Chapel Hill milk shed. After further discussion a motion was made by Alderman Fitch and seconded by Alderman Davis that the milk producers be allowed forty-five days extension to correct whatever faults might exist at the end of which time full inspection should be made and the Board would expect the conditions to be improved so that they would be allowed to extend a higher grade. This motion was passed by the Board in the affirmative. Dr. Richardson then asked to be relieved of all the responsibility of the milk production in the Chapel Hill shed and upon motion of P. L. Burch, seconded by F. O. Bowman and approved by the Board his request was granted.

There being no further business the meeting adjourned.

The Board of Aldermen held a special meeting in the Town Hall on September 4, 1942 with Mayor Madry presiding and the following Aldermen present: Messrs. F. O. Bowman, G. O. Davis and R. B. Fitch. Also present were Dr. Richardson and Mr. Foard of the State Health Department.

Subject: Health Department

Dr. Richardson was present and reported that the milk situation was apparently going along nicely and asked reinstatement of the Health Department as the enforcement agency for the Milk Ordinance. The Board passed a motion made by Alderman Bowman and seconded by Alderman Davis to restore the enforcement of the Milk Ordinance to the Health Department with instructions to enforce according to the Ordinance and Code.

There being no further business, the meeting adjourned.
