Minutes Regular Meeting Board of Alderman--Chapel Hill, N. C. October 23, 1950

The regular meeting of the Board of Aldermen was held in the Town Hall on October 23rd at 8:00 P.M.

Present were Mayor Lanier, Aldermen Fitch, Hobbs, Burch, Davis, and Putnam, Town Manager Rose, Town Attorney Hinshaw, and Town Auditor Peacock.

Mr. Rose read a letter from the Chapel Hill School Board in answer to a request for a school attendance officer from the Negro Civic Club, which had been referred to the School Board. They stated that no funds were available in the school budget for a truant officer for the current year. Mr. Rose was requested to send a copy of this letter to the members of the Negro Civic Club.

The Fire Chief's report for the months of August, September, and October was read by Mr. Rose.

Mr. Peacock gave the auditor's report for the month of September, and stated that he had examined the vouchers for September and had found them to be in order with the exception of one small item for gravel, which was not accompanied by an invoice.

Mr. Rose reported that he had talked with the bus driver of the Chapel Hill Transit Lines, Inc., and he said that Mr. Hastings was giving up the busses and going to Florida. The bus driver stated that he was operating on a cash basis and asked that he be allowed to run until Mr. Muirhead comes back from Scotland. Mr. Rose said that he then called Mr. Copeland of the Lennox Development Corporation in Durham, and Mr. Copeland stated that Mr. Muirhead was very anxious to keep the busses running and that he would make sure that stated that he is allowing the busses to continue running until a new franchise can be drawn up.

Mr. Rose presented each member with a copy of a proposed permit for use of the town buildings. It was thought that when the permit is approved, there should be three copies--one of the Town Manager's office, one for the Police Department, and one to present

to the users. Also, it was suggested that there should be a notation making the users responsible for the building during the time of their meeting. Mr. Fitch suggested that it might be advantageous to make out an application in preference to a permit.

Mr. Hobbs brought up the question of building a wall and planting trees in the point leading to the Airport Road, as he said that this was, at the present, an unsightly spot. Mr. Rose was asked to look into this and present an estimate of the cost to the Board.

Mr. Putnam reported that the Jaycees had put up about 120 street markers without any difficulty, and that they hoped to complete the job without too much delay.

Mr. Lanier stated that he had been to Raleigh, North Carolina and that it had been brought to his attention that the minutes of the Board of Alderman was handled in a different manner from that of the Chapel Hill Board of Alderman. It is the practice there for the Clerk to make a copy of the minutes and send it out to each member, to be read before the meeting and approved, or corrected, at the following meeting. Mr. Lanier stated that he mentioned this only as a thought for the future.

Mr. Lanier presented a letter from the North Carolina Department of Public Welfare in which they stated that the Military Order of the Purple Heart had not been licensed to solicit funds in the State of North Carolina. They stated in this letter that this organization had been notified last year and this year that they were not eligible for a license.

Upon motion of Mr. Putnam, seconded by Mr. Davis, and unanimous consent, the meeting was adjourned at 8:55 P.M. o'clock.
