# Minutes Regular Meeting Board of Alderman--Chapel Hill, N. C. November 13, 1950

The regular meeting of the Board of Aldermen was held in the Town Hall on November 13th at 8:00 P.M.

Present were Mayor Lanier, Aldermen Fitch, Hobbs, Burch, Davis, and Fowler, and Town Attorney Hinshaw.

The minutes of the regular meeting of October 23rd were read and approved.

Robert Pendergraft came before the Board with a written petition that he be granted a license to operate two taxicabs in the Town of Chapel Hill. He explained that he was buying one of these cabs from the Independent Cab Company, but would operate under the name of the Custom Cab Company. Mr. Hobbs made the motion that Robert Pendergraft's request for a taxicab license be granted, subject to his provision of insurance called for in the Taxicab Ordinance. This motion was seconded by Mr. Davis and passed unanimously.

The Health Department's report for October was read by the Clerk.

The combined report of the Police Department and the Clerk of Court for the month of October was passed to each member present.

Mr. Burch moved that the Town Manager's recommendation for the appointment of Eric Crabtree as Fireman for the Town of Chapel Hill at a salary of \$40 per week be approved. This motion was seconded by Mr. Fitch and passed unanimously.

Mr. Hobbs moved that the recommendation of the Recreation Commission to appoint Mrs. E. G. McGavran to fill the unexpired term of Mr. L. V. Huggins on the Recreation Commission be approved. This was seconded by Mr. Davis and unanimously passed.

Mr. Lanier presented to the members of the Board maps being made for the Chapel Hill Planning Board by F. Stuart Chapin, Jr. and explained the purpose of the Planning Board's project for the year. It was brought out that the Planning Board had not presented

a budget for the year 1950-51 for approval of the Board. No action was taken on this matter, but Mr. Lanier stated that he would try to straighten out the matter and report back to the Board at the next meeting.

There was some discussion about disposing leaves from lots and sidewalks. Also, the Board discussed the possibility of a Burning Permit to issue to people so that they can burn their leaves. No action was taken.

Mr. Lanier asked the Board's opinion of installing a television set in the Fireman's quarters upstairs in the Town Hall. The Firemen are willing to buy the set if they are allowed to use it upstairs. They want to borrow the money out of a Fireman's Insurance Fund and pay it back, but there was some question about them being allowed to borrow this sum for that purpose. Mr. Burch stated that Mr. Sparrow was going to Raleigh to find out whether or not they could borrow the money out of this Fund. The Board stated that, without a formal motion, it is sympathetic with the idea of the Firemen installing a television set in their private quarters on the second floor of the Town Hall. No other action was taken.

Mr. Burch moved that the Board require that the excavated lot on the corner of West Franklin and Robinson Streets be made safe for the public by building a protective fence or wall, subject to the approval of the Town Manager. This motion was seconded by Mr. Hobbs and unanimously passed.

The following persons were appointed by the Mayor, with the Board's approval, to serve on the Special Committee on Street Names: J. M. Saunders, Zeb Council, Miss Josephine Pritchard, Harry Wolfe, and L. J. Phipps. The Committee is to elect its own Chairman, study the problem of re-naming some of the streets in Chapel Hill, and present their report to the Board of Alderman by the 1st of February, 1951. The Board will then approve, disapprove, or offer suggestions on the report.

Mr. Lanier passed a copy of the Municipal Roads Commission's Report to the Governor to each member for his careful study.

The Board set December 11, 1950 as the date on which they will be glad to hear anybody that wishes to express an opinion, pro or con, concerning the continuation of rent control in Chapel Hill after December 31, 1950.

Upon motion of Mr. Burch, seconded by Mr. Fitch, and unanimous consent, the meeting was adjourned at 10:10 P.M. o'clock.

# THE INSENSATE PLOT

The attempted assassination of President Truman was not only shocking; it was mystifying and senseless. So far as he was concerned, in a personal and official capacity, he was the last person that Puerto Ricans honestly seeking the independence of the island should have attacked. His record from the beginning of his term showed willingness and even determination to give Puerto Rico whatever status her people desired. appointed the first native ever to be Governor; he encouraged Congress to pass legislation giving Puerto Ricans the right to elect their own officers and to vote for a Constitution of their own creation. The first step in this direction will be taken tomorrow, when there is a referendum to discover whether Puerto Ricans really want a Constitution. In his special message to Congress on Oct. 16, 1945, Mr. Truman left it open for Puerto Rico to become hat was visited

Neither he nor Americans generally, therefore, need feel any qualms of conscience about Puerto Rico. The island could not possibly exist by itself, and up to the present an overwhelming majority of the inhabitants have rejected independence. The legitimate Independentista party could only get about 10 per cent of the votes at the 1948 election, and did not elect a single candidate.

Part of the injustice and senselessness of the plot and of this week's uprising lies in the fact that the Nationalists are a small, lunatic-fringe group with no mass following. They polled 500 votes at the last elec-tion and have a member-ship of much less than l,000. Pedro Albizu Cam-pos, the leader, who lived in the same Bronx tenement house as one of the assassins, is a man with a fixation. The illegitimate child of a Spanish father and a Negro mother, he became obsessed by racial and social prejudice against him, and turned them into a hatred of the United States. Frustrated, sensitive, egomaniatic, he was believed in his own greatness and in the right of Puerto Rico to freedom. His American education helped him to mislead ignorant or half-aducated followers. His dedication to the cause he championed and his willingness to suffer or even die for it are what made his leadership so dangerous.

That the Cuban House of Representatives should have asked the Puerto Rican Government to guarantee the lives of Albizu Campos and his associates, and that the Cuban President should have transmitted the message to San Juan, will be considered shockingly irresponsible.

by all Americans. President Prio Socarras received the reply from Gov. Muñoz Marin that he deserved.

The part that Puerto Rico Communists played in the present developments is far from clear, but it was obviously a vicious one. The Nationalists are ignorant or misguided fools; the Communists know what they are doing. There probably are not more than 200 of them in Puerto Rico but they have access to outside advice and funds, which cannot be said of the Nationalists.

It all adds up to a sordid, insensate picture in which President Truman had no logical place. However, it is often in the nature of political assassination to aim at a symbol. Terrorism is frequently a gesture in which the individual victims are considered impersonally. They have to pay the price for the supposedly valid revolutionary goal. The remarks of Mrs. Collazo, wife of one of the assassins, proves the extent to which blind fanaticism and stupidity dominated the action.

That does not make the plot and the loss inexcusable; it merely helps to explain to normal human beings how such things can happen. They are aberrations, and no one with any sense of justice is going to blame Puerto Ricans as a whole or allow this burdens to delay the progress toward self-rule and economic betterment. It will not be forgotten that a regiment of Puerto Ricans has been fighting gallantly in Korea, and that the Puerto Rican people are good, decent, law-abiding American citizens. Gov.
