#### RESOLUTION CONCERNING THE COLLECTION OF DELINQUENT TAXES DUE THE TOWN OF CHAPEL HILLS

WHEREAS, the Town Manager reports to this Board, from the Auditor's Reports, that for 1943 and prior years uncollected taxes due the Town of Chapel Hill amount to \$7, 171.00, and that uncollected taxes for 1914-19, inclusive, amount to \$14,505.00 --- or a TOTAL of \$21,976.00; and

WHEREAS, unpaid taxes are unfair to those taxpayers who have paid their taxes, and are a hardship on the financial operations of the Town, and are a reflection on this Board; and

WHEREAS, the Town Manager and the Town Attorney need be in no doubt about the attitude of this Board and its moral support of them in this matter; THEREFORE,

BE IT RESOLVED.

That the Board of Aldermen of the Town of Chapel Hill hereby and now directs the fown Manager and the Town Attorney, individually and jointly, to proceed at once to collect all delinquent taxes, and that they use all the legal means at their disposal to collect all delinquent taxes due the Town of Chapel Hill.

SECOND, That the Town Manager and the Town Attorney report to this Board on March 12, 1951, the items of delinquent taxes collected during the Month of February, 1951; on April 9, the items of delinquent taxes collected during the month of March; on appeal May 14, on items paid during the month of April; etc., through the month of June, 1951.

# Minutes Regular Meeting Board of Alderman--Chapel Hill, N. C. January 23, 1951

The regular meeting of the Board of Alderman was held in the Town Hall on January 23th at 8:00 P.W.

Present were Mayor Lanier, Aldermen Fitch, Hobbs, Burch, Davis, Fowler, and Putnam, Town Manager Rose, and Town Attorney Hinshaw.

The minutes of the regular meeting of January 8th were read and approved.

Mr. Rose introduced Mr. Burton Jones, Professor of Mathematics at the University of North Carolina, who came before the Board regarding a sewer connection for a residence he proposes to build on Vance Street Extension. After discussing this matter, Mr. Putnam moved that this request be referred to the Utilities Committee for their recommendation at the next meeting of the Board. This motion was seconded by Mr. Burch and passed unanimously. Mr. Rose was asked to notify Mr. Jones of the Committee meeting in order that he may attend if he desires.

Mr. Rose read a petition from the merchants and property owners on West Franklin Street from the corner of Strowd's Motor Company to Graham Street requesting whiteway lights in this section. A committee of the following men came before the Board to consult with the members on this petition: Kenneth Check, Long Meadow Farms; F. E. Strowd, Johnson-Strowd-Ward; J. C. Fox, Village Pharmacy; David Carter, Hospital Saving Association; James R. Farlow, Attorney; William Alexander, B F Goodrich Dealer; Herbert Pendergraft, Village Service Station; Herman H. Ward, Caston Motor Company; and Mr. W. G. Fields. Mr. Rose reported that he had investigated the possibility of installing lights along this section, but that there would have to be more investigation before he could present figures to the Board. Mr. Burch stated that that end of town was growing so rapidly that he would like to see suitable lighting facilities installed as soon as possible. After discussing this matter, Mr. Putnam moved that the petition be referred to the Utilities Committee. This motion was seconded by Mr. Burch and unanimously passed.

Mr. David Carter, representative of the Hospital Saving Association came before the Board to ask their permission to contact employees of the Town in regard to joining Hospital Saving as a group.

He stated that 65% must be willing to join before it could be offered. He further stated that the Hospital Saving policy would take up where the Workmen's Compensation leaves off. After discussing this matter with Mr. Carter, Mr. Hobbs moved that Mr. Carter be encouraged to form a unit with most of the employees, telling them that the amount of the policy will be deducted out of their salary each month. This was seconded by Mr. Putnam and passed unanimously.

The Health Officer's report for the month of December was read by Mr. Rose. Mr. Fitch made the observation that the Health Department's report should give the bacteria count. The members of the Board asked Mr. Rose to remind the Health Officer of this in connection with future reports.

The Fire Chief's report from December 9, 1950 to January 21, 1951 was read by Mr. Rose. Mr. Rose reported that he had purchased a small fire extinguisher for each police car and hopes to save trips of the fire truck in cases of small fires when an extinguisher is all that would be necessary. The Fire Chief also included an attendance report in which the average attendance was

Mr. Rose read a letter addressed to Mr. W. T. Sloan, Chief of Police, from the Department of Motor Vehicles, Raleigh, North Carolina, stating that no fatal accidents had been reported from the Town of Chapel Hill in 1950, and that this put the Town in line for an Honor Roll Plaque from the National Safety Council.

Mr. Rose reported that Mr. H. C. McAllister was exactly 195 feet from the sewer line, and, therefore, the Board would not have to take any action on his letter.

Mr. Rose presented each member with a statement of expenditures up through December, 1950.

Mr. Rose reported that the new bookkeepping machine arrived Saturday and that he is waiting on Mr. Cavin to come over to install it so that it can be used.

Mr. Rose presented a request from the residents of Cobb Terrace to make the circle a one-way street. Mr. Hobbs moved that the Attorney be requested to draft an Ordinance and present it at the next meeting of the Board making traffic one-way on Cobb Terrace. This motion was seconded by Mr. Putnam and unanimously passed.

Mr. Rose stated that the outside woodwork on the Town Hall needs painting, but that he would make a report on this at a later meeting.

Mr. Rose reported that Mr. Fussler had requested that a light be installed opposite the driveway that goes into his property off Tenney Circle. Mr. Eurch moved that Mr. Fussler's request for a street light be referred to the Utilities Committee. This motion was seconded by Mr. Putnam and passed unanimously.

Mr. Rose stated that Mr. John W. Umstead had asked him to remind all the members of the Board to get any local bills they wanted to see introduced to him within ten days.

Mr. Hobbs, Chairman of the Finance Committee, presented each member with a copy of a report of the Finance Committee meeting held on January 15th. Mr. Hobbs moved that the following Resolution be passed:

BE IT RESOLVED: That the Board of Alderman of the Town of Chapel Hill hereby and now directs the Town Manager and the Town Attorney, individually and jointly to proceed at once to collect all delinquent taxes, and that they use all the legal means at their disposal to collect all delinquent taxes due the Town of Chapel Hill.

This motion was seconded by Mr. Davis and unanimously passed.

Mr. Rose read a letter that he had written to go to all delinquent taxpayers. He stated that it was his intention to have this letter mimeographed and mailed to all persons owing taxes to the Town of Chapel Hill.

Mr. Burch moved that the Town Manager be authorized and directed to discontinue marbage collection service on March 10, 1951 for all individuals and firms which are now delinquent; and that, hereafter, the marbage collection charge shall be paid annually in advance of service rendered. Also, that delinquent firms or individuals be notified of the discontinuation by letter, and that a copy of this letter be sent to the Health Department. This motion was seconded by Mr. Fowler and unanimously passed.

Mr. Hobbs moved that the Town Manager be authorized to purchase two new sewage pumps for replacements at the Westwood pumping station. This motion was seconded by Mr. Fitch and passed unanimously.

Mr. Rose reported that he had verbal permission from all property owners to build an alley behind the Durham Products' Building on Franklin Street, but that Mr. Abernethy would not give his signature to a right of way. The Board asked Mr. Hinshaw to get easement papers for all the owners to sign, otherwise, the alley will not be built by the Town.

Mr. Burch, Chairman, reported that the Safety Committee was not ready to report on the parking problem on Rosemary Street.

Mr. Fitch suggested that the Board set a definite time and ask residents in one block of Rosemary Street to meet with the Board in regard to widening Rosemary Street. It was decided that at the next meeting, the Board would set a date to invite the people to come in and talk with the Board members.

Mr. Rose asked the Board when he could move the tree on East Franklin Street in front of Mrs. Louis MacMillan's home. The Board suggested that he wait until the Highway Department gets ready to start work there.

Upon motion of Mr. Putnam, seconded by Mr. Burch, and unanimous consent, the meeting adjourned at 10:30 P.M. o'clock.
