Minutes Regular Meeting Board of Aldermen-Chapel Hill, N. C. March 24, 1954

The regular meeting of the Board of Aldermen was held in the Town Hall on March 24, 1954 at 7:30 o'clock p.m.

Present were Mayor Lanier, Aldermen Wager, Burch, Cornwell, Putnam and Robinson, Town Attorney LeGrand, Town Auditor Peacock, and Town Manager Rose.

The minutes for the regular meeting of March 8, 1954 were approved as read and amended.

Dr. W. H. Plemmons, Chairman of the Citizens Advisory Committee on Trees and Shrubs, came before the Board to give the committee's second report on their work. Mr. Cornwell moved that the Committee be thanked for their work and that the Town will attempt to expedite everything they recommend and ask them to continue. Mr. Putnam seconded the motion and it was passed unanimously.

Mr. M. J. Dawson came before the Board requesting that he be permitted to cut Elizabeth Street down in order to extend the street. Mr. Rose read a letter from Mr. Holloway also recommending the cut and the grading of Holloway Street. Mr. Putnam moved the matter be referred to the Street Committee to look into the situation with the Town Manager and report back at the next meeting. Mr. Cornwell seconded the motion and it was passed unanimously. Mr. Dawson stated that if the Board could not give him an answer then that it could be dropped.

Mr. Rose read a letter from James Street concerning the up-rooting of trees during the curb and gutter construction, and a bill for fixing his rock wall. No action was taken.

Mr. Rose read a letter from Mr. Raymond Kaighn about the drainage on his property on Dogwood Drive, and a letter from Mr. W. C. George about the Town maintaining Evergreen Lane.

Mr. Robinson brought up the matter of Clara Edwards steps being torn down during the curb and gutter project. Mr. Rose stated that he will look into the situation.

Mr. Peacock gave the Auditor's report for the month of February.

Mr. LeGrand brought up the matter of sidewalk paving in Chapel Hill. After considerable discussion Mr. Putnam moved that it be referred to the Planning Board for their study and recommendation to the Board, concerning paving the sidewalk area on Franklin Street. Mr. Cornwell seconded the motion and it was passed unanimously.

Mr. Rose gave the figures for the sale of \$30,000 note. The note was sold to the Wachovia Bank and Trust Company.

A letter of resignation from Mr. M. M. Fitch from the Town Planning Board was read. Mr. Cornwell moved the resignation be accepted and that a letter be written Mr. Fitch. Mr. Putnam seconded the motion and it was passed unanimously.

Mr. Rose reported that Earl Bush has resigned from the Police Force and Amos Horne has been hired for a 90 day trial period. Mr. Putnam moved that the provisional appointment of Amos Horne be approved. Mr. Cornwell seconded the motion and it was passed unanimously.

The matter of the University National Bank being used as a depository for Town funds was discussed. Mr. Cornwell moved that the University National Bank be accepted as a depository. Mr. Putnam seconded the motion and it was passed unanimously.

Mr. Putnam asked that the Street Committee, along with the Town Manager study the parking near the entrance to the Hill House on West Franklin Street.

Mr. Wager brought up the matter of a date for the hearing for the proposed Planning Board. Mr. LeGrand presented an ordinance to establish a Planning Board for Chapel Hill and its environs. The matter of an ordinance for the Planning Board was discussed. Mr. Cornwell moved that a Special Meeting of the Board of Aldermen be held on March 29, 1954 at 7:30 p.m. to consider the Planning Board. Mr. Putnam seconded the motion and it was passed unanimously.

Upon motion by Alderman Putnam, seconded by Alderman Burch, and unanimous consent the meeting was adjourned at 9:55 o'clock p.m.

After hearing the minutes for the meeting of March 24, 1954, read on motion made by Alderman **Kolinson**, seconded by Alderman the minutes were approved by vote of the Board of Alderman, this the 12th day of April, 1954.
