# MINUTES

Board of Aldermen

Town of Chapel Hill, N.C.

The Board of Aldermen met at a Special Meeting at the Town Hall on July 28, 1958, at 8:00 P.M., o'clock with the following present: Mayor Cornwell; Aldermen Giduz, Walters, Wager, Robinson and Strowd; Town Attorney LeGrand and Town Manager Rose. Absent: Alderman Davis.

Mayor Cornwell stated that the purpose of the meeting was to consider the adoption of the Estimated or Tentative Budget for 1958-59.

Alderman Giduz discussed the possibility of raising the present rate of \$0.95 on each \$100.00 to \$1.00 per \$100.00. Alderman Giduz moved the adoption of the following with Section 4 to read General Fund to \$0.77 and Debt Service to \$0.23:

AN ORDINANCE APPROPRIATION FUNDS FOR THE FISCAL YEAR BEGINNING JULY 1, 1958, AND ENDING JUNE 30, 1959, AND TO LEVY TAXES TO RAISE REVENUE FOR SAID FISCAL YEAR.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL:

# Section I

That for the purpose of operating the Town Government of the Town of Chapel Hill and its activities for the fiscal year ending June 30, 1959, the amounts set forth in the column designated as "Approved ... 1958-59", of the attached "Proposed Budget, 1958-59", the total amount of which items is \$451,576.28,

or so much of each item thereof as may be necessary, are hereby appropriated. The attached schedule, designated as "Proposed Budget, 1958-59", is incorporated herein and made a part of this ordinance.

#### Section II

That for the said fiscal year ending June 30, 1959, there is hereby appropriated out of the General Fund the total amount of \$380,203.00, which amount is hereby divided among and allocated to the several departments and activities of the Town in the respective amounts appearing in the column designated as "Approved ... 1958-59", in the attached proposed budget referred to in Section 1 above.

## Section III

That for the said fiscal year there is hereby appropriated out of the Debt Service Fund the following:

Payments of interest on outstanding bonds ....\$27,173.28

Payments of principal on outstanding bonds .... 44,000.00

Handling charges .... 200.00

# Section IV

That in order to raise revenue to meet the expenses of the Town Government of the Town of Chapel Hill and its activities as provided in the above sections of this ordinance for the fiscal year ending June 30, 1959, there is hereby levied the following rates of tax on each \$100.00 valuation of taxable property property located in the Town of Chapel Hill, as listed for taxes on January 1, 1958:

For the general operating expenses of the Town (General Fund) ...... \$ 0.77

For the payment of principal and interest on outstanding debt (Debt Service Fund) ...... 0.23

Total \$ 1.00

## Section V

That in order to raise revenue for the general operating expense of the Town of Chapel Hill there is hereby levied a poll tax of \$1.00 on all male persons between the ages of 21 and 50,

unless exempt as provided by law.

Alderman Wager moved the adoption of the following:

AN ORDINANCE TO LEVY A PRIVILEGE TAX ON TRADES, PROFESSIONS AND FRANCHISES FOR THE FISCAL YEAR ENDING JUNE 30, 1959.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILL:

Section I

There is hereby levied a Privilege License Tax on trades and professions carried on and franchises enjoyed within the Town of Chapel Hill for the fiscal year ending June 30, 1959, at the same rate or rates effective for such taxes during the fiscal year ending June 30, 1958, and as are set forth in the "License Tax Schedule for North Carolina Cities and Towns, 1953", prepared by the North Carolina League of Municipalities in Report No. 77, dated July, 1953, which is on file in the Office of the Town Clerk of the Town of Chapel Hill; and the "Revenue Ordinance for License Taxes", contained and set forth in said Report No. 77, and all provisions thereof except that portion on Page 23 of said Report which has been striken out and marked "deleted", are hereby adopted, incorporated herein by reference and made a part of this ordinance, effective for the fiscal year ending June 30, 1959. Provided, however, that any disabled veteran or blind person as defined in the General Statutes of North Carolina, Section 105-53 (F) who holds a certificate of exemption from peddler's tax duly issued by the Board of County Commissioners of Orange County may be exempt from payment of peddler's tax to the Town of Chapel Hill.

Adopted this the 28th day of July, 1958 seconded by Alderman Strowd, and unanimously adopted.

Alderman Walters moved the adoption of the following:

AN ORDINANCE TO LEVY A TAX ON DOGS

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF CHAPEL HILE:

There is hereby levied for the fiscal year ending June 30, 1959, a tax on all dogs within the Town of Chapel Hill, at the following rates:

- 1. On all male dogs ..... \$ 1.00
- 2. On all female dogs..... 2.00

Adopted this the 28th day of July, 1958. seconded by Alderman Robinson, and unanimously adopted.

Subsistence Pay for Police Officers
The matter was discussed with Mr. E. E. Peacock and Town Attorney LeGrand who established that this pay must be incident to such officers line of duty. Mayor ornwell stated that more study should be made. Mr. Peacock recommended that Accounts 501 & 502 be changed to read Salaries and Subsistence until such time as the matter may be adopted or eliminated.

Parking Meters

A group of merchants appeared before the Board of Aldermen objecting to Parking Meters. They presented a signed petition. Aldermen Giduz moved that this petition be received and filed, seconded by Alderman Strowd and passed.

Alderman Strowd moved the adoption of the following:

AN ORDINANCE RELATING TO PARKING ON SOUTH COLUMBIA STREET BETWEEN FRANKLIN STREET AND CAMERON AVENUE

BE IT ORDAINED by the Board of Aldermen of the Town of Chapel Hill:

# Section I

It shall be unlawful for any person to park an antomobile or motor vehicle of any kind at any time on the West side of South of South Columbia Street (between Franklin Street and Cameron Avenue) between a point on the west curb line of said street at the southern line of Fraternity Court and the northern line of Cameron Avenue.

#### Section II

It shall be unlawful for any person to park an automobile or motor vehicle of any kind at any time on the East side of South Columbia Street between a point thereon opposite the southern line of Fraternity Court (if extended eastwardly to the eastern line of South Columbia Street) and the northern line of Cameron Avenue.

# Section III

It shall be unlawful for any person to park an automobile or motor vehicle of any kind for a period of more than two hours at any time on the West side of South Columbia Street between a point thereon marking the northern line of Beta Theta Pi Fraternity property and a point thereon marking the southern line of Fraternity Court, and all parking within said area shall be parallel to the curb, facing in a southwardly direction, with

the right front and rear wheels of said vehicle being within twelve (12) inches of said curb.

#### Section IV

It shall be unlawful for any person to park an automobile or motor vehicle of any kind for a period of more than two hours at any one time on the East side of South Columbia Street between a point thereon which is opposite the northern property line of Beta Theta Pi Fraternity (if extended eastwardly to the eastern curb of South Columbia Street) and a point on said eastern curb line which is opposite the southern line of Fraternity Court (if said southern line of Fraternity Court were extended eastwardly to the eastern curb line of South Columbia Street) and all parking within said area shall be parallel to the curb, facing in a northwardly direction, with the right front and rear wheels of said vehicle being within twelve (12) inches of the eastern curb line of said street.

# Section V

Each and every violation hereof shall be punishable by a fine of one dollar (\$1.00).

# Section VI

All ordinances in conflict herewith are hereby repealed. seconded by Alderman Robinson, and unanimously adopted.
