Board of Aldermen

Town of Chapel H,11, N.C.

The Board of Aldermen met at a Public Hearing on May 23, 1960, at 7:30 P.M o'clock in the Town Hall with the following present: Mayor Cornwell; Aldermen Robinson, Walters, Wager, McClamroch, Giduz, and Strowd. Town Attorney LeGrand and Town Manager Rose. Planning Board members present were: Messrs. Umstead, chairman; Foushee, and Alexander; Executive Secretary David Neville.

Mayor Cornwell stated the purpose of the Public Hearing was to consider five (5) areas for rezoning:

- 1. From RA-20 Residential to Business: An area near University Heights at the intersection of the Old and New Durham Highways, see attached description. Alderman Giduz moved that the request be referred to the Planning Board for recommendation, seconded by Alderman McClamroch, and passed.
- 2. From RA-10 Residential to RA-20 Residential; All the area of Tenney Circle extending to the depth of all lots facing on Tenney Circle. Alderman Walters moved that the request be referred to the Planning Board for recommendation, seconded by Alderman Robinson, and passed.
- 3. From Agricultural to RA-10 Residential: The area known as Estes Hills extension, bounded on the North by Estes Drive extended, on the West by the Barnett property on the South by Cole Spring Branch and on the East by Caswell and Granville Roads. Alderman McClamroch moved that the request be referred to the Planning Board for recommendation, seconded by Alderman Strowd, and passed.
- 4. From Agricultural to RA-20 Residental: An area known as Coker Hills, bounded by Eastwood Lake, Lake Forest Estates, Estes Hills subdivision, I. W. Pritchard Estate and Estes Hills School property. Alderman Robinson moved that the request be referred to the Planning Board for recommendation, seconded by Alderman McClamroch, and passed.
- 5. From Agricultural to RA-15 Residential: An area North East of Ridgefield Extension and containing about thirty one (31) acres. Alderman Strowd moved that the request be referred to the Planning Board for recommendation, seconded by Alderman McClamroch, and passed.

The Public Hearing being at an end, the meeting was adjourned at 7:45 P.M. o'clock.

The Board then convened in a Regular Meeting.

Oral Petitions

Mrs. David Davis representing the Recreation Commission, came before the Board in the matter of a summer playgrounds program. She stated that it will be hadly needed as the University Swimming Pool will be closed to children; that such program would run from July 11 to August 19th and would require the servicesof two qualified instructors at a cost of about \$300.00, which amount is requested from the Town of Chapel Hill. The request was referred to the Finance Committee for study.

Written Petitions

North Side School- Mayor Cornwell stated that the P.T.A. has requested sidewalks from Church and McDade Street north to McMasters; West on McMasters Street to the rear of North Side School, also from corner of Church Street and School Lane west on School Lane to front of North Side School. The matter was referred to the Street Committee and Town Manager to proceed as study shows need.

Mitchell Lane Improvements

Town Manager stated that in order for the State Highway Commission to proceed with the proposed plan to improve Mitchell Lane, it will be necessary for the Town to indemnify and save harmless the State Highway Commission in the amount of \$1,000.00 on account of any claim from Sam Barbee. Alderman Giduz moved that the Board accept Town Manager's recommendation to underwrite an amount, if necessary, net

to exceed \$1,000 if and should litigation arise, seconded by Alderman Walters, and passed.

Alderman McClamroch moved that the recommendation of Judge Wm. S. Stewart to establish a Vice-Recorder to act in the absence of the Recorder, be accepted; that such persona when he serves should be recompensed from the Recorder's salary, seconded by Alderman Wager, and passed. Alderman Walters moved that Judge Wm. S. Stewart's recommendation to appoint Robert B. Midgette as Vice-Recorder, be accepted, seconded by Alderman McClamroch, and passed.

Annexation Petition - Ridgefield Extension
Town Manager stated that the sole owner of Ridgefield Extension
petitions to have this area annexed to the Town. Alderman McClamroch
moved that a Public Hearing to consider the petition be set for the
13th day of June, 1960, seconded by Alderman Strowd, and passed.
Five members of the Board voted "aye", Alderman Giduz voted "nay".
The motion was passed.

Annexation - Knolls Development

A motion to set a date for a public hearing to consider a petition for annexation of the Knolls Development area was defeated.

Appointments to Recreation Commission
Mayor Cornwell stated that the terms of three members of the commission expire. He recommended that Mrs. David Davis, Adolphus Clark and Robert Culton be reappointed. Alderman Wager moved that the Mayor's recommendation be accepted, seconded by Alderman Strowd, and passed. Later in the meeting Mrs. David Davis informed the Board that because of ill health she cannot continue on the commission. Mr. Robert D. Bøyce was recommended as a person to replace Mrs. Davis.

Parking at Rosemary Street Apartments
Town Manager stated that cars park in front of the Rosemary Street
Apartments rather than across the street in the parking lot which is
completed; that he believes this in violation of a Town Ordinance.
The Board requested that this matter be checked.

Fire District
Mayor Cornwell stated that the Lake Forest Estates area want to come within the Greater Chapel Hill Fire District. The Board discussed appointing a committee to meet with the people of that area, but postponed action until the Town's Fire Class rating be settled.

Street Committee

Alderman Robinson discussed need for sidewalk by North Side School, also street lights in that area; that Brooks Street be opened into Church Street; that Tom Battles, Mrs. Foust and Lee Franklin have drainage problems that should be remedied.

Alderman Giduz stated that request should be made to the State Highway Commission for grading a sidewalk on the North side of Orange County Project 8.14546. The Board agreed that the finished surfacing to the walk could be done by the Town. He also request that detailed requirements in the matter of Urban Renewal (public housing) be studied.

There being no further business to be considered at this time, the meeting was adjourned at 8:57 P.M. o'clock.
