A special meeting of the Board of Aldermen of the Town of Chapel Hill, North Carolina, was held at the Town Hall, the regular place of meeting, at 4:30 o'clock P.M., on December 5, 1963,

Present: Mayor Roland McClamroch, presiding, and Aldermen Roland Giduz, Joe Page, Paul Water, F. E. Strowd and Hubert Robinson.

Absent: Mrs. Adelaide Walters

"Adelaide Walters, who is not present, has signed the following acknowledgment of service of the meeting:

Alderman Strowd introduced the following resolution which was read:

RESOLUTION DIRECTING DEPOSIT OF \$1,200 TO THE CREDIT OF THE TOWN OF CHAPEL HILL PARKING FACILITY REVENUE BONDS INTEREST AND REDEMPTION FUND

Board of Aldermen of the Town of Chapel Hill, North Carolina, on August 12, 1963, sutherizing the issuance of \$80,000 Parking Facility Revenue Bonds, provides for the deposit of the sum of \$1,200, simultaneously with the delivery of the bonds, to the credit of the Town of Chapel Hill Parking Facility Revenue Bonds Interest and Redemption Fund for payment of the interest on the bonds to January 1, 1964, said date being not later than six (6) months after the date by which it was expected that the Parking Facility would be completed; and

WHEREAS, the notice of the sale of said bonds stated that delivery of the bonds would be made on or about October 22, 1963; and

WHEREAS, the Town has been unable to obtain the title to the property required for the Parking Facility in accordance with the provisions of the resolution authorizing the issuance of the bonds but will be able to obtain title to said property by a date not later than December 31, 1963; and

WHEREAS, the Town has available for deposit to the credit of said Interest and Redemption Fund an additional \$1,200 for the payment of the interest on the bonds to July 1, 1964; and

WHEREAS, the purchaser of the bonds, the Chapel Hill Parking Association, Chapel Hill, North Carolina, has consented to the delay in the delivery of the bonds and the deposit of the additional \$1,200 to the credit of said Interest and Redemption Fund; now, therefore,

BE IT RESOLVED by the Board of Aldermen of the Town of Chapel Hill:

Section 1. The fown Clerk is hereby directed to deposit from available funds of the Town, simultaneously with the delivery of said \$80,000 Parking Facility Revenue Bonds, the sum of \$1,200 to the credit of the Town of Chapel Hill Revenue Bonds Interest and Redemption Fund.

Section 2. This resolution shall become effective upon its passage.

Alderman Giduz moved the passage of the foregoing resolution entitled: "RESOLUTION DIRECTING DEPOSIT OF \$1,200 TO THE CREDIT OF THE TOWN OF CHAPEL HILL PARKING FACILITY REVENUE BONDS INTEREST AND REDEMPTION FUND" and Alderman Wager seconded the motion and the resolution was passed by the following vote:

Alderman Giduz moved the adoption of the following ordinance:

AN ORDINANCE TO AMEND THE "ORDINANCE TO APPROPRIATE FUNDS AND TO RAISE REVENUE FOR THE FISCAL YEAR BEGINNING JULY 1, 1963

AND ENDING JUNE 30, 1964".

BE IT ORDAINED by the Board of Aldermen of the Town of Chapel Hill:

SECTION I.

That the Budget Ordinance adopted July 23, 1963 and subsequently amended is hereby further amended by increasing account number 7261 "Off Street Parking" by \$1200.00 and decreasing account number 8000 "Contingencies" by \$1200.00.

SECTION II.

All ordinances in conflict herewith are hereby appealed.
