MINUTESBoard of AldermenTown of Chapel Hill

The Board of Aldermen met at a special meeting at 4:20 P.M., November 17, 1969 at the Town Hall with the following members present: Mayor Lee, Aldermen Scroggs, Prothro, Smith, Coxhead, Nassif and Ethridge. Also present were Town Manager Peck, Town Clerk Roberts and Town Attorney Denny.

DRUGS

Joe Hakan, representing the Drug Action Committee, told the Board that the committee was doing important work in education and rehabilitation but needed financial assistance in order to maintain a 24-hour phone service manned with persons knowledgeable in the matter of drugs to be of service to persons using drugs or their parents. He said that this would be supervised by M.D.'s and manned by volunteers approved by them. He asked that the Board appropriate about a thousand dollars for this purpose. Alderman Smith asked how many parents were involved. Mr. Hakan estimated between one hundred and four hundred based on the attendance at various meetings held. Alderman Coxhead said that certain specific appropriations might be made but not a general appropriation for such a purpose to be spent by the committee. The Board asked that this be put on the agenda for the next regular meeting.

SUBDIVISION-COKER WEST

Mayor Lee told the Board that the developers of Coker West requested name change from Darlington Drive to Rock Creek Road. Alderman Prothro moved, seconded by Alderman Coxhead that this be approved. This was unanimously carried.

TOWN HALL BIDS

Tom Bridges, of City Planning and Architectural Associates, presented the bids that had been received for construction of a new Municipal Building. The low bidders and their base bids were: General Contractor, C. T. Wilson of Durham, \$366,631. Plumbing, Faulk Plumbing and Heating of Garner, \$18,250. Heating and Air Conditioning, Carolina Air Conditioning of Durham, \$41,997. Electrical, Bryant-Durham Electric of Durham, \$41,300. He recommended that alternates 4 and 5 for dark anodized aluminum rather than plain aluminum and bronze glass rather than plain glass amounting to \$2,423 and \$800 respectively be accepted. He told the Board that Wilson had not had a bid on the vinyl covered walls in alternate 6 but had informally quoted a price for about \$2,000 for this and suggested this be handled later in a change order rather than an alternate at this time. The total cost of the building with an architects fee at 6.9 per cent would amount to something between \$503,000 and \$504,000. Aldermen Nassif and Ethridge both spoke in favor of alternates 4 and 5. Alderman Nassif moved, seconded by Alderman Prothro to accept the low bids from each prime contractor and alternates 4 and 5 as part of the base and authorize the Mayor and Town Clerk to sign the contracts subject to approval by the architect of such things as the necessary bond, insurance, list of sub-contractors and materials and so forth required by the specifications and to provide the additional money from current funds from the 1969-70 budget and 1970-71 budget. This motion was unanimously carried. Mr. Bridges told the Board that it would take about three weeks to get a go ahead order and that the specifications called for completion within 360 days of that time.

LAND USE PLAN

Pearson Stewart and Jim Rathburn of the Research Triangle Planning Commission presented a draft of a general statement concerning Land Use development. A special meeting was set for 4:00 P.M. Thursday, November 20, 1969 to discuss this further.

POLICE DEPARTMENT

Alderman Nassif said he wished to commend the Mayor and the Police Chief and members of the Police Department for the way they had handled the trouble in the past week. He asked that a listing of Police overtime be prepared for the Board. Mayor Lee said that he would like to have a vote of appreciation to the Police Chief and the members of the Department and asked that a resolution be prepared accordingly for the next meeting.


STOP SIGNS-CAMERON AVENUE
